# Cyclone Recovery – Proposal to fund regional recovery projects

1 This paper seeks agreement to a fiscally neutral transfer of \$10.000 million between Vote Business, Science and Innovation appropriations to fund a package of projects to support regional recovery from Cyclone Gabrielle.

#### **Relation to government priorities**

2 This paper concerns the Government's ongoing recovery to this year's North Island Weather Events (NIWE).

## **Executive Summary**

- 3 In February 2023, Cabinet established a tagged contingency (\$75.000 million) to provide short term funding support for flood recovery, mental wellbeing and business advice and support. Most of this tagged contingency was distributed in the form of business support grants and \$10.000 million of underspend was transferred into the 2023/24 financial year.
- 4 I propose that this \$10.000 million is utilised to fund nine regional recovery projects in Northland, Hawke's Bay, and Tairāwhiti. The funding will provide:
  - business continuity and resilience advice and support;
  - regional tourism recovery programmes;
  - flood and cyclone infrastructure resilience;
  - flood and cyclone damage remediation; and
  - training and accommodation support for the flood and cyclone rebuild workforce.
- 5 I am also seeking agreement to the establishment of a new appropriation in Vote Business, Science and Innovation and a fiscally neutral transfer between appropriations to enable the projects to be funded.

#### Background

- 6 Cyclone Gabrielle caused severe flooding in the northern and eastern parts of the North Island from 12-16 February 2023, compounding damage from the Auckland Anniversary floods on 27 January 2023 (in combination referred to as the "North Island weather events").
- 7 The Government has funded and undertaken a broad array of activities to support communities and businesses in both the immediate response phase and within the recovery phase. This includes, in February 2023, establishing a tagged contingency *Cyclone Gabrielle: To provide for interim business and primary sector support for the impacts of Cyclone Gabrielle and other recent weather events not covered by the Auckland Package* in Vote Business, Science and Innovation [CAB-23-MIN-0044 refers].
- 8 The tagged contingency was initially \$50.000 million and was subsequently increased to \$75.000 million. This tagged contingency was available to provide the following short term supports:

- discretionary funding for flood recovery
- business continuity and resilience advice and support, and
- mental wellbeing support.

- Cabinet authorised the Prime Minister, the Deputy Prime Minister, the Minister of Finance, Minister for Regional Development, Minister for Economic Development and Minister of Agriculture (Joint Ministers) to:
  - draw down from the tagged contingency and to establish any appropriation as necessary to give effect to this business and primary sector recovery package; and
  - determine the distribution of the contingency funding for the business and primary sector recovery package.

# Discretionary funding for flood recovery

- 10 Joint Ministers agreed to allocate most of the tagged contingency to discretionary funding for flood recovery. An interim recovery package was established under a new appropriation, *Cyclone – Business support for the impacts of Cyclone Gabrielle and January 2023 weather events* (the appropriation) to provide support for businesses impacted by the NIWE.
- 11 The Ministry of Business, Innovation and Employment (MBIE) distributed approximately \$65.000 million in business support grants via Local Delivery Partners (LDPs). These grants were provided to businesses requiring financial support in the immediate aftermath of the NIWE. By the end of the 2022/23 financial year, \$10.000 million remained in the appropriation. The Minister of Finance approved an in-principle expense transfer of the \$10.000 million underspend into the 2023/24 financial year. (Briefing 2223-4463 refers)
- 12 LDPs have noted that the quality of applications deteriorated towards the end of the funding period. This indicates that most businesses eligible for a business support grant have been covered by the scheme and that the \$65.000 million already distributed represents the effective maximum of value of the grants that are required.
- 13 Consequently, I directed officials to provide the Minister of Finance and I with advice on options for distributing the remaining \$10.000 million. We agreed that our preferred approach is to fund a regional recovery package of projects rather than continue with business support grants. I am seeking Cabinet's agreement to that approach and the creation of a new appropriation to fund the regional recovery package.

# Funding a regional recovery package

14 MBIE's Regional Economic Development and Investment Unit (Kānoa) has identified nine projects in Northland, Hawke's Bay, and Tairāwhiti as suitable for funding as part of a regional recovery package. These projects have the benefit of being ready to commence, will be delivered in the short term, and will make an immediate contribution towards recovery and resilience in the affected regions.

- 15 The Department of the Prime Minister and Cabinet's Cyclone Recovery Unit (CRU) has reviewed the regional recovery projects proposed in this paper to check for their correlation with the relevant regional recovery plans and found that all of the proposals appear sensible and are critical enablers to economic recovery in the regions mentioned. Their analysis is included in Table 1 below.
- 16 Broadly, the projects outlined in Table 1 below fund:
  - business continuity and resilience advice and support;
  - regional tourism recovery programmes;
  - flood and cyclone infrastructure resilience;
  - flood and cyclone damage remediation; and
  - training and accommodation support for the flood and cyclone rebuild workforce.

New Vote Business, Science, and Innovation appropriation

- 17 The projects that form the regional recovery package are not able to be funded from within the existing Cyclone Gabrielle appropriation, so I propose the creation of a new appropriation within Vote Business, Science, and Innovation. This new appropriation will be limited to providing support for regions impacted by Cyclone Gabrielle and the January 2023 weather events.
- 18 As the \$10.000 million was subject to an expense transfer, Cabinet agreement is required to a further transfer between appropriations. I am, therefore, proposing Cabinet agree to a fiscally neutral transfer of \$10.000 million between appropriations to fund the regional recovery package outlined above.

# **Financial Implications**

- 19 This proposal will create a new appropriation within Vote Business, Science and Innovation and then reprioritise \$10.000 million with a fiscally neutral transfer between appropriations within Vote Business, Science and Innovation.
- 20 An early confirmation of this transfer will be required (prior to the October Baseline Update) as there will be insufficient funding in the new appropriation.

# **Population Implications**

21 Officials assess that there are limited population implications arising from this proposal.

## **Cost-of-Living Implications**

22 Officials assess that there a limited cost-of-living implications arising from this proposal.

## **Use of External Resource**

23 One external resource, who has been engaged as extra capacity to support the cyclone and flood response and recovery within MBIE, prepared this paper.

## Consultation

24 This paper was prepared by MBIE. The following agencies were consulted: the Department of the Prime Minister and Cabinet, and the Treasury.

25 I intend to announce the package of initiatives.

#### Recommendations

I recommend the Committee:

- 1 **note** that, in February 2023, a tagged contingency *Cyclone Gabrielle: To* provide for interim business and primary sector support for the impacts of *Cyclone Gabrielle and other recent weather events not covered by the Auckland Package* was established in in Vote Business, Science and Innovation;
- 2 **note** that the Prime Minister, the Deputy Prime Minister, the Minister of Finance, Minister for Regional Development, Minister for Economic Development and Minister of Agriculture (Joint Ministers) agreed to allocate most of the tagged contingency to discretionary funding for flood recovery;
- 3 **note** that Joint Ministers created the *Cyclone Gabrielle Business support for the impacts of* Cyclone *Gabrielle and January 2023 weather events* appropriation in Vote Business, Science, and Innovation to provide support for

businesses impacted by Cyclone Gabrielle and the January 2023 weather events;

- 4 **note** that the Minister of Finance approved an in-principle expense transfer of a \$10.000 million underspend from the *Cyclone Gabrielle – Business support for the impacts of* Cyclone *Gabrielle and January 2023 weather events* appropriation into the 2023/24 financial year;
- 5 **note** that funding of \$10.000 million is sought for a package of nine regional recovery projects in Northland, Hawke's Bay and Tairāwhiti;
- 6 **agree** to the allocation of the remaining \$10.000 million of discretionary funding for flood recovery to the package of regional recovery projects in Northland, Hawke's Bay, and Tairāwhiti;
- 7 **note** that the Department of the Prime Minister and Cabinet's Cyclone Recovery Unit (CRU) has reviewed the regional recovery projects proposed in this paper to check for their correlation with the relevant regional recovery plans and found that all of the proposals appear sensible and are critical enablers to economic recovery in the regions mentioned.
- 8 **agree** to establish the following new appropriation in Vote Business, Science, and Innovation to give effect to the regional recovery package:
