Response to Review of Out of Hours Immigration Compliance Activity

Portfolio Immigration

On 18 September 2023, Cabinet:

- 1 **noted** that on 1 August 2021, the Prime Minister apologised to Pacific people for the harm caused to them by the Dawn Raids period of the 1970s;
- 2 **noted** that following "out of hours" compliance activity in April 2023 by Immigration New Zealand, the Ministry of Business, Innovation and Employment (MBIE) commissioned Michael Heron KC to undertake a review of that activity and to make recommendations, if warranted;
- 3 **noted** that Michael Heron KC's review found that no change had been made to the settings for out of hours compliance activity to align with the apology;
- 4 **noted** that Michael Heron KC's review made four recommendations to change operational practice and one recommendation for the government to consider legislative change to limit the scope of this activity;
- 5 **noted** that the four recommendations to change operational practice are being implemented;
- 6 **agreed** that the Immigration Act 2009 should be amended, to require a judicial warrant to be sought for out-of-hours compliance activity, and that this change should be progressed through a stand-alone bill, to be passed as soon as possible in the next Parliamentary term;
- 7 **directed** MBIE officials to commence work on developing the above legislative change, and to report back to the Minister of Immigration by 30 November 2023, with specific recommendations for progressing the amendment legislation.
