Fair Pay Agreements Act Repeal Bill: Approval for Introduction

Portfolio Workplace Relations and Safety

On 11 December 2023, Cabinet:

- 1 **noted** that on 4 December 2023, Cabinet agreed that a Bill repealing the Fair Pay Agreements (FPA) legislation be passed before the end of 2023 [CAB-23-MIN-0470];
- 2 **noted** that the Fair Pay Agreements Act Repeal Bill repeals:
 - 2.1 the Fair Pay Agreements Act 2022, including reversing any consequential amendments made to other Acts under the Fair Pay Agreements Act 2022;
 - 2.2 the Fair Pay Agreements Regulations 2022, and reverses any amendments made by the Employment Court (Fair Pay Agreements) Regulations 2023 and the Employment Relations Authority (Fair Pay Agreements) Amendment Regulations 2023, with the exception of a technical amendment made by the Employment Court (Fair Pay Agreements) Regulations 2023 to express the figures for Employment Court fees in GST-exclusive form [CAB-23-MIN-0470];
- 3 **approved** the Fair Pay Agreements Act Repeal Bill [PCO 25950/6.0] for introduction, subject to the final approval of the Government caucuses and sufficient support in the House of Representatives;
- 4 **agreed** that the Bill be introduced on 12 December 2023;
- 5 **noted** that to repeal the FPA legislation by Christmas 2023 the Bill will need to pass through all parliamentary stages under urgency;
- 6 **agreed** that the Government proposes that the Bill be enacted before the House rises for the 2023 Christmas period.
