# Immigration (Infringement Offences, Fees, and Forms) Amendment Regulations 2024

Portfolio Immigration

On 7 March 2024, the Cabinet Legislation Committee:

- 1 noted that in March 2020, the Cabinet Economic Development Committee agreed to amend the Companies Act 1993, the Immigration Act 2009 and the Employment Relations Act 2000 to deter employer non-compliance with immigration and employment law [DEV-20-MIN-0034];
- 2 **noted** that in September 2022, Cabinet approved the introduction of the Worker Protection (Migrant and Other Employees) Bill, which became law on 6 July 2023 introducing three new employment immigration infringement offences to the Immigration Act 2009 to proportionately respond to lower-level offending against migrant workers by employers [CAB-22-MIN-0415];
- 3 **noted** that to enable immigration officers to issue infringement notices for the new employment infringement offences, the form of infringement notices and reminder notices must be prescribed in regulations under section 400 of the Immigration Act 2009;
- 4 **noted** that the Immigration (Infringement Offences, Fees, and Forms) Amendment Regulations 2024 give effect to the decisions in paragraphs 1 and 2 above;
- 5 **authorised** the submission to the Executive Council of the Immigration (Infringement Offences, Fees, and Forms) Amendment Regulations 2024 [PCO 26069/11.0];
- 6 **noted** that the Immigration (Infringement Offences, Fees, and Forms) Amendment Regulations 2024 come into force on 11 April 2024.
