Building Fire Safety Work Programme: Update

Portfolio Building and Construction

On 1 May 2024, the Cabinet Economic Policy Committee (ECO):

- 1 **noted** that officials have been supporting the Regulations Review Committee with a complaint relating to the fire safety provisions in the Building Code;
- 2 **noted** that the Minister for Building and Construction intends to return to ECO in September 2024 with a discussion document on the issues with the fire safety provisions in the building code;
- 3 **noted** that the Loafers Lodge fire raised concerns with independently qualified persons not complying with the building warrant of fitness regime;
- 4 **noted** that in August 2023, the previous government agreed:
 - 4.1 to amend the Building Act 2004 to clarify the obligations of independently qualified persons in issuing a 12A form;
 - 4.2 to introduce a new standard offence for independently qualified persons who negligently issue a 12A form for a specified system where the inspection, maintenance, and reporting procedures of the compliance schedule for that system have not been fully complied with in the previous 12 months;
 - 4.3 that the penalty for this offence is a fine not exceeding \$50,000 for an individual and \$150,000 for a body corporate;
 - 4.4 to increase the fine for buildings owners for failing to supply the territorial authority with a building warrant of fitness from \$250 to \$1,000;
 - 4.5 to increase the fine for building owners for failing to display a building warrant of fitness that is required to be displayed from \$250 to \$1,000;

5 **noted** that the decisions in paragraph 4 above are to be included in the Building (Earthquake-prone Building Deadlines and Other Matters) Bill, which holds a category 3 priority on the 2024 Legislation Programme (to be passed by the end of 2024);

- 6 **noted** that the Ministry of Business, Innovation and Employment is working with territorial authorities to find non-legislative ways to improve the consistency of the independently qualified persons regulatory system;
- 7 **noted** that Operation Magazine, in which an inspection was undertaken of buildings similar to Loafers Lodge throughout New Zealand to identify and address any immediate fire safety concerns, highlighted issues in the fire safety regulation settings;
- 8 **noted** that the Ministry of Business, Innovation and Employment is developing guidance for territorial authorities based on the findings from Operation Magazine.
