Minimum Wage Review: Setting the 2025 Rates

Portfolio Workplace Relations and Safety

On 9 December 2024, following reference from the Cabinet Economic Policy Committee, Cabinet:

- 1 **noted** that the Coalition Agreement between the National Party and New Zealand First commits to 'moderate increases to the minimum wage every year';
- 2 **noted** that the Ministry of Business, Innovation and Employment (MBIE) has provided the Minimum Wage Review 2024, attached to the submission under CAB-24-SUB-0489, and has recommended a two percent increase in the minimum wage, to \$23.60 per hour;
- 3 **noted** that in setting the rates that will apply for the next year, the Minister for Workplace Relations and Safety (the Minister) believes it is important for Cabinet to consider the forecast rate of inflation, which is currently trending downwards, and current high unemployment rates, which have been driven by years of high inflation, high government spending, and low growth;
- 4 **agreed** that the adult minimum wage rate be set at \$23.50 per hour (1.5 percent increase);
- 5 **agreed** to maintain the starting-out and training minimum wage rates at 80 percent of the adult minimum wage;
- 6 **agreed** that the minimum wage rate adjustments referred to in paragraphs 4 and 5 above will come into effect on 1 April 2025;
- 7 **invited** the Minister to issue drafting instructions to the Parliamentary Counsel Office for an Order in Council to give effect to the above decisions;
- 8 **authorised** the Minister to make decisions, consistent with the policy outlined in the paper under CAB-24-SUB-0489, on any issues that arise during the drafting process;
- 9 **directed** MBIE and Treasury to provide advice to the Minister and the Minister of Finance on the impact of New Zealand's minimum wage on wage compression, productivity, and incentives for people to upskill or seek promotion, before the next Minimum Wage Review is delivered.
