Purpose

To seek your agreement to proactively release the Immigration (Fiscal Sustainability and System Integrity) Amendment Bill (the Bill) Cabinet paper and associated Regulatory Impact Statements (RISs) to a small number of organisations as part of the upcoming targeted consultation on an exposure draft of the Bill.

Recommended action

Background

- 1. On 18 September 2024, Cabinet agreed to policy proposals for the Immigration (Fiscal Sustainability and System Integrity) Amendment Bill (the Bill). Cabinet also agreed to you undertaking targeted consultation on an exposure draft of the Bill in December 2024 [ECO-24-MIN-0198].
- 2. You have agreed to release a copy of the final Cabinet paper and Regulatory Impact Statements (RISs) to targeted consultees in confidence, shortly before they receive the exposure draft of the Bill [2425-0891].
- 3. This briefing outlines the high-level approach planned for targeted consultation and seeks your agreement to release key documents (with redactions) to targeted consultees.

Planned approach to targeted consultation

- 4. With your agreement [2425-0286], we met with the following stakeholders in August 2024 to advise them of the high-level proposals and to prepare them for the exposure draft of the Bill later in the year:
 - BusinessNZ
 - the Employers and Manufacturers Association
 - the New Zealand Council of Trade Unions
 - the Casey Review Focus Group
 - the Office of the Ombudsman
 - the New Zealand Law Society
 - INZ's Immigration Focus Group
- 5. We intend to reengage these same stakeholders in late November ahead of receiving the exposure draft from the Parliamentary Counsel Office (PCO) in early December. The consultation process would involve:
 - sharing key background policy documents (see section below) in advance of the exposure draft
 - organising an upfront meeting with stakeholders to discuss the proposals where requested,
 - sharing the exposure draft of the Bill and requesting feedback in a specified format in early December, and
 - meeting with stakeholders to discuss their feedback in mid-December.
- 6. We anticipate the consultation to provide visibility of areas of challenge or controversy that we may expect in Select Committee.
- 7. We will brief you early in the New Year on the outcome of the consultation and any areas where amendments to the policy are recommended in light of stakeholder feedback.

Proposed documents for release to targeted consultees

8. MBIE seeks your agreement to release the following documents to the targeted consultees ahead of consultation on the exposure draft of the Bill, to support stakeholders' understanding of the rationale for the proposals in the Bill, and to maximise the quality of feedback stakeholders are able to provide during the limited time available for targeted consultation:

Recommended redactions

Grounds for withholding information

- 9. We propose redactions to some information on the grounds that it would be withheld under the following sections of the Official Information Act 1982 (the OIA) if requested under the OIA:
 - section 6(a) where the release of this information would prejudice the security or defence of New Zealand or the international relations of the Government
 - section 6(b) where the release of this information would prejudice the entrusting of information to the Government on a basis of confidence by the Government of any other country or any international organisation
 - section 6(c) where the release of this information would prejudice the maintenance of the law
 - section 9(2)(f)(iv) to protect the confidentiality of advice tendered by Ministers of the Crown and officials
 - section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions, and
 - section 9(2)(h) to maintain legal professional privilege.

Information proposed to be withheld under active consideration

- 10. Most of the information we propose withholding relates to work that is currently underway and under active consideration such as:
 - further advice on the best legislative vehicle (either this Bill or a wider review of the Immigration Act 2009 later in 2025) to;
 - consider the penalties associated with migrant exploitation offences and determine whether they adequately reflect its seriousness and whether the maximum limits for deportation liability are adequate, and
 - adjust the definition of a mass arrival, to include people arriving on a scheduled service (such as a commercial aircraft or a cruise vessel¹),
 - the 2025 immigration fee and levy review.

Information we propose to release

11. We propose to release information relating to the fiscal management plan where work is still underway. This was previously released as part of the 2024 Immigration Fee and Levy Review announcement and proactive release and is intended to be complementary to the increases in fee and levies and key to ensuring a sustainable and self-sufficient system. There is low risk with releasing this information as it is already in the public domain.

Potential risks in releasing the information and mitigations

12. We note there are some potential risks associated with the release of this information, which we have outlined below alongside mitigations:

Potential risk	Risk Rating	Mitigation
Stakeholders might release information provided in confidence to the media/their stakeholders.	Low	Reiterate in all communications and engagements that the information is being shared in confidence. We judge this risk to be low given recent engagement with these groups who have adhered to the confidentiality requested.

Consultation

13. Ministry of Justice, Inland Revenue, Ministry of Education, Department of Corrections, Department of the Prime Minister and Cabinet (DPMC), New Zealand Intelligence Community, New Zealand Police, Ministry of Foreign Affairs & Trade and internal MBIE (Legal, Communications and Te Whakatairanga Service Delivery Group (TWSD)), were consulted on the release of this information.

¹ Subject to Cabinet's agreement to this proposal ahead of targeted consultation (as expected), we will verbally test this proposal with stakeholders.

Next steps

- 14. If you agree to proactively release the Cabinet paper, Cabinet minute and associated RISs, they will be provided to the targeted consultees in confidence. While the exact timing of the consultation on the exposure draft is uncertain (as it is dependent on PCO's drafting progress), we will notify your office when the timing for consultation becomes clearer and the relevant documents are due to be shared.
- 15. There are also a number of policy decision-making papers relating to the Bill, which will go through the standard proactive release process and will be published on MBIE's website in early 2025, when the Bill is introduced. We will provide more information and proposed redactions on those papers in February 2025.
