To provide you with a draft Cabinet paper which seeks agreement to amend the definition of a mass arrival group in the Immigration Act 2009, via the *Immigration (Fiscal Sustainability and System Integrity) Amendment Bill* [FSSI], Confidential advice to Government



A draft Cabinet paper is attached for your consideration

- Cabinet has recently agreed to the substantive outline of the Immigration (Fiscal Sustainability and System Integrity) Amendment Bill (FSSI) [ECO-24-MIN-0198]. We are working with MBIE Legal and the Parliamentary Counsel Office (PCO) on drafting, and are on track for the exposure draft to be ready to consult with targeted stakeholders in early December.
- 2. This briefing seeks your agreement to, or feedback on, a paper seeking further decisions from Cabinet.

The Cabinet paper adjusts the definition of a mass arrival group

- 3. You have recently agreed to amend the existing definition of a mass arrival group, to remove the risk that a group that should be subject to a group warrant of detention may arrive on a scheduled international service and therefore not meet the existing definition [0004179]. Given the national security implications of a mass arrival, you directed us to develop a Cabinet paper to seek that decision, and a draft is attached at **Annex One**.
- 4. As you will recall, the paper proposes the removal of section 9A(2) of the Immigration Act 2009 (the Act). As a result, any irregular arrival of more than 30 people will be able to be treated as a mass arrival group, even if they have arrived on a scheduled international service. Irregular in this context means people who arrive at the border and are not granted entry permission, but who cannot be turned around as they have lodged claims for refugee or protected person status.) This reflects the evolution of organised global people smuggling, which is increasingly using standard commercial services to enter countries.



We recommend you circulate the paper

9. The Ministers of most of the agencies that have been consulted in the development of the Cabinet paper and the wider FSSI Bill are members of the ECO. The two Ministers that are not are the Minister of Customs (who is also an Associate Minister of Immigration) and the Minister of Health and Pacific Peoples. We therefore recommend that you consider also circulating the paper to Ministers Reti and Costello.

Next steps

- 10. We will provide you with a briefing early next week [REQ-0002932] that seeks your direction on whether to progress further policy proposals through the FSSI Bill. That briefing will also ask you to agree to two refinements to Cabinet's policy decisions, in line with the authorisation you have to make decisions, consistent with the policy proposals in the paper under ECO-24-SUB-0198, that may arise during the drafting and consultation process [ECO-24-MIN-0198, paragraph 14].
- 11. We are continuing to work with PCO to develop and refine the drafting of the FSSI Bill. If PCO considers that there are any other matters where more specificity is required, it is possible that we may need to seek your agreement to further policy decisions before the exposure draft is finalised. We are working to minimise the likelihood of this happening.
- 12. The key milestones for the project are set out in the table below:
