- 1. Your office has completed ministerial consultation on the draft Cabinet paper seeking agreement to amend the definition of a mass arrival group via the *Immigration (Fiscal Sustainability and System Integrity) Amendment Bill (the FSSI Bill)*, Confidential advice to Government [0005298].
- 2. While no feedback was received as part of the ministerial consultation process, you have directed a wording change, which has been incorporated.
- 3. Following a final peer and legal review, we have made other minor changes to the final version, including upgrading its classification to *Restricted* to protect the discussion about the changing risk profile of people smuggling internationally. Confidential advice to Government

The paper is now ready for lodgement.

4. We have prepared draft talking points to support you in your discussion at the Cabinet Economic Policy Committee (ECO), and these are attached at **Annex One**, and the final version of the Cabinet paper for lodgement is attached at **Annex Two**.

Next steps

- 5. The Cabinet should be lodged by 10am on Thursday 7 November 2024.
- 6. Following ECO's and Cabinet's consideration of the proposals, we will work with MBIE Legal to develop drafting instructions for Parliamentary Counsel Office (PCO) as soon as possible, with the aim of, if possible, including this change in the exposure draft of the Bill.
- 7. The key upcoming milestones for the project are set out in the table below:

Annex One: Draft talking points for Cabinet Committee

Amending the definition of an immigration mass arrival

- You will be aware that people smuggling is a huge business for transnational criminal networks.
- New Zealand has fortunately never experienced a mass arrival of asylum seekers.
 Such an arrival would be immensely disruptive. It could also raise questions about the security of our borders.
- We have provisions in the Immigration Act 2009 (the Act) to enable us to manage a mass arrival safely and humanely. In particular, the Act allows for group warrants of detention, for a group of 31 people or more who arrive "irregularly" specifically, not on a commercial service.
- Parliament passed an amendment to those provisions earlier this year.

[*If needed:* that amendment extended the length of time that a mass arrival group could be detained without a warrant, so the individuals could access meaningful legal representation.

Confidential advice to Government, Legal professional privilege

 I am now seeking a further change, to be included in the Bill I am taking to Parliament in a few months. It responds to changes in international smuggling trends – National security or defence

 I therefore ask you to agree to the Act being amended so that 31 or more people arriving off a <u>commercial</u> flight, or cruise vessel, and claiming asylum at the border can also, if necessary, be managed by our mass arrival provisions.
