On 13 March 2025, the Cabinet Legislation Committee:

- 1        **noted** that on 5 December 2024, the Petitions Committee referred the Petition by Christian van der Pump, entitled: *Remove Building Act 2004 restriction of access to the District or High Court* (the Petition) to the Minister for Building and Construction for the Government's response;
