Privacy of natural persons

Thank you for your request to the Ministry of Business, Innovation and Employment (MBIE) on 18 November 2024 requesting, under the Official Information Act 1982 (the Act), the following information:

- 1) *Data regarding the number of deportations over the last 10 years, broken down by year and nationality.*
- 2) *Data regarding the number of deportations over the last 10 years of people who were deported because they were convicted.*
- 3) *Data regarding the number of deportations over the last 10 years, by year, of people who were deported because they overstayed their visas and what their nationality is.*

Our Response

The data¹ you have requested relating to deportations is provided to you in the tables in the Appendix.

Please note that the term "deportation" covers unlawful migrants, most of whom have interacted with MBIE prior to their departure from New Zealand. This information shows all Compliance cases with any of the following case closure outcomes:

- **Client Deported** – A person who is unlawfully in New Zealand who has been served a deportation order and departs New Zealand, or a temporary visa holder who was made liable for deportation and departs New Zealand after the date when they may be served with a deportation order.
- **Client Self-Deported** – A person who is unlawfully in New Zealand who departs New Zealand of their own volition and at no cost to the Ministry after the date when the person may be served with a deportation order, but they have not been served with such an order.
- **Voluntary Departure** – A person who is unlawfully in New Zealand or is a temporary visa holder who was made liable for deportation and departs of their own volition and at no cost to the Ministry prior to the date when the person may be served with a deportation order.

In relation to questions two and three, it is important to note that criminal offenders may be deported for reasons other than their criminal offending, e.g. individuals who were deported as a result of their

unlawful status in New Zealand but who may also be criminal offenders. Therefore, there may be some overlaps in the data provided to you. However, where possible, if a person has been recorded as having a criminal conviction, they have been removed from list in question three.
