# New Zealand Companies Office Fees and Levies Review (2025): Release of Discussion Document

#### Portfolio Commerce and Consumer Affairs

On 14 April 2025, the Cabinet Business Committee:

### Consulting on the Companies Office Fee and Levy Review

1 **approved** the release of the discussion document Review of New Zealand Companies Office Fees and Levies (2025), attached as Appendix One to the paper under CBC-25-SUB-0008, for public consultation over a period of six weeks ending in May 2025, subject to any minor or technical changes that the Minister of Commerce and Consumer Affairs may approve prior to publication;

### Amending the Financial Service Providers Fees Regulations

- 2 **agreed** that the supplementary fee of \$39.38 including GST for requesting a criminal history check for Finance Service Providers (FSPs) be amended in the FSP fees regulations to align with the cost set by the Ministry of Justice for third-party criminal history checks of \$11.30 plus GST;
- 3 **agreed** that all other changes in the FSP fees regulations be amended to be expressed as GST exclusive, instead of inclusive, amounts;
- 4 **invited** the Minister of Commerce and Consumer Affairs to issue drafting instructions to the Parliamentary Counsel Office to give effect to paragraphs 2 and 3 above;
- 5 **authorised** the Minister of Commerce and Consumer Affairs to make decisions on any minor or technical matters that may arise during the drafting process.
