# Introduction

The International Visitor Conservation and Tourism Levy (IVL) is a \$35 levy charged to most international visitors to Aotearoa at the time they apply for their visas or New Zealand Electronic Travel Authority (NZeTA).

The IVL came into effect in 2019. It ensures that international visitors contribute to tourism and conservation projects that benefit communities, visitors and the environment.

Revenue generated from the IVL is split equally (50:50) between conservation projects (administered by the Department of Conservation) and tourism projects (administered by the Ministry of Business, Innovation and Employment).

# WHAT IS THE IVL?

The revenue collected via the IVL funds a series of targeted, prioritised investments that can span multiple financial years. Investment decisions are made jointly by the Minister for Tourism and Hospitality and Ministers of Conservation and Finance (the joint IVL Ministers). The IVL is not a contestable fund

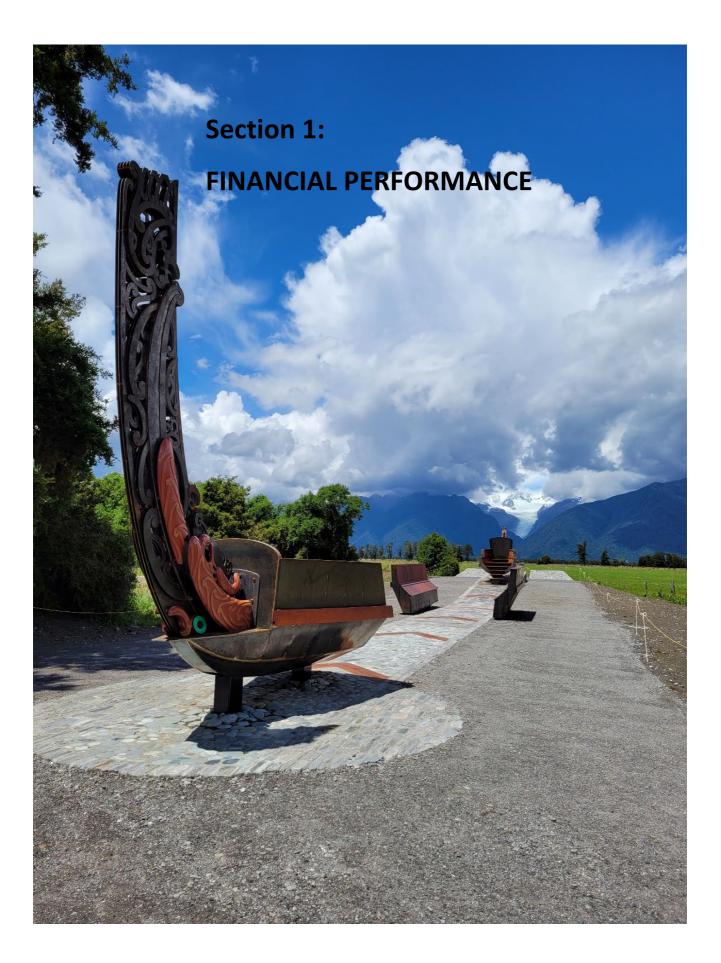
The joint IVL Ministers set long-term objectives and funding priorities for the IVL. The Ministry of Business, Innovation and Employment (MBIE) and the Department of Conservation (DOC) provide advice to the joint IVL Ministers on the alignment of projects to these objectives and priorities. MBIE and DOC also provide project oversight, reporting, compliance and monitoring services.

The investment priorities target areas of cultural and historic significance, the restoration and protection of New Zealand's unique biodiversity, upgrades to existing tourism destinations and transformational technologies.

The investment priorities are guided by key frameworks reflecting government objectives for conservation and tourism. These include: the New Zealand-Aotearoa Government Tourism Strategy; Te Mana o te Taiao – the New Zealand Biodiversity Strategy 2020; and the DOC Heritage and Visitor Strategy.

# **IVL PROJECTS**

In 2019, an initial round of 10 multi-year projects were funded from the IVL. Due to the significant reduction in revenue caused by COVID, there were no additional projects funded until 2021/22. This report covers four of the original 2019 projects which are still running, plus seven new tourism projects approved in 2021/22 and 2022/23.



# **Financial Performance**

This section covers:

- revenue and expenditure for the IVL in 2023/24
- budgeted, actual and forecast expenditure for the IVL projects

# Revenue

Revenue collected in the fifth year of operation to 30 June 2024 was \$62.5m, down on the forecast of \$70m. This is a significant increase on 2022/23 from \$44.8m.

# Expenditure

This financial year, expenditure for tourism was \$1.9m across nine projects, expenditure for conservation was \$16.58m across 15 projects, including administrative expenditure of \$2m.

# Funding allocated to out-years

Many of the IVL projects have multi-year funding committed in principle. Administrative expenditure is also committed in advance. As at 30 June 2024, the IVL has funding allocated out to financial year 2028/29.

Total funding allocated to future years as at 30 June 2024 is \$160.223m across both tourism and conservation. Tourism projects have \$101.974m committed over the next four financial years, conservation projects have \$44.334m committed over the next 5 financial years. Administrative funding has been committed for the next 5 financial years, totalling \$13.915m out to 2028/29.

# New projects approved in 2023/24

Listed below are the new projects that were approved during the 2023/2024 financial year from the conservation and tourism portfolio.

# Conservation portfolio

- Car Park Charging Pilot \$3.78m. To pilot paid parking at three South Island visitor hotspots to help manage visitor pressure and support conservation.
- Huts of Recreational Importance \$4.20m. To support the maintenance and management of Huts of Recreational Importance through partnerships over the next four years.
- Nationwide campaign to connect New Zealanders to nature \$5.00m. To get more action for nature by raising awareness and creating motivation for people to connect with nature.
- Redeveloping and maintaining the track at Cathedral Cove \$5.00m. To support continued recovery from Cyclone Gabrielle damage and create a visitor management plan.
- Continuing delivery of the Tongariro Alpine Crossing Sustainable Management Plan \$1.88m.
- Enhancing existing iconic short walks and day hikes \$6.00m. To enhance existing iconic tracks and expand existing iconic tracks network.
- Increasing efforts to keep Aotearoa free from sea spurge \$1.28m. To expand the programme to monitor and eradicate sea spurge along New Zealand's coastline.
- Foundational work for the eradication of pigs, cats and mice from Auckland Island / Maukahuka \$3.65m. To establish organisational readiness for the eradication of mammalian predators from Auckland Island in the Sub Antarctic.
- Lake Waikaremoana Great Walk reopening, reimagining and Te Urewera pest control plan \$1.73m. To enable the reopening of Lake Waikaremoana Great Walk, to reimagine the visitor experience and to aid with pest control planning on the Great Walk.<sup>1</sup>
- Tongariro Alpine Crossing sustainable management project \$1.83m. To work in partnership with Ngāti Hikairo of Ngāti Tūwharetoa to develop a sustainable management model for the Tongariro Alpine Crossing (TAC).
- National Wilding Conifer Control Programme \$8.05m. To provide additional maintenance control of wilding conifers in 2023/24 on public conservation land.
- Biodiversity Investment Approach project \$2.24m. To develop a multi-year biodiversity investment planning system that enables the Government, DOC and partners to make better informed and transparent decisions on biodiversity investment.
- Information Systems Services improvement package to update or replace key information technology and systems:
  - o 5 Minute Bird Count data upgrade \$0.345m.

- Connections for Conservation Treaty Partner and stakeholders relationship management software improvements \$0.173m.
- Discover the Outdoors upgrade \$0.173m.
- Geographic Information Systems upgrade \$0.702m.
- New Zealand Threat Classification System upgrade \$0.345m.
- Department of Conservation Website upgrade \$0.575m.
- Marine Reserve Monitoring data improvements \$0.098m.
- Cyclone response biodiversity priorities \$0.575m. To protect species under threat due to damage from Cyclone Gabrielle.
- Hauraki Gulf marine protection \$1.605m. To establish marine protection and develop a research and monitoring framework across the whole Revitalising the Gulf strategy.
- Te Manahuna Aoraki project \$0.575m. To protect and revitalise protecting a 310,000-hectare mainland island in the Upper Mackenzie Basin and Aoraki/Mount Cook National Park.<sup>2</sup>

# Tourism Portfolio

- Electrifying the New Zealand Cycle Trail \$3m. To increase usage of the New Zealand Cycle Trail (NZCT) to derive more economic benefits for Great Rides communities.
- Regional Events Promotion Fund \$5m. To support the promotion of regional events to the domestic market.
- International Visitor Conservation and Tourism Levy investment in Nga Haerenga New Zealand Cycle Trails Great Rides \$40m. To continue to support trail enhancements, maintenance, extreme weather repairs and supporting the trail governing body NZCT Inc.
- Investment in NCEA programme of learning for tourism \$2m. To progress procurement for a secondary school programme of learning in tourism.
- Tourism New Zealand \$42m. To support marketing New Zealand as a Visitor Destination.

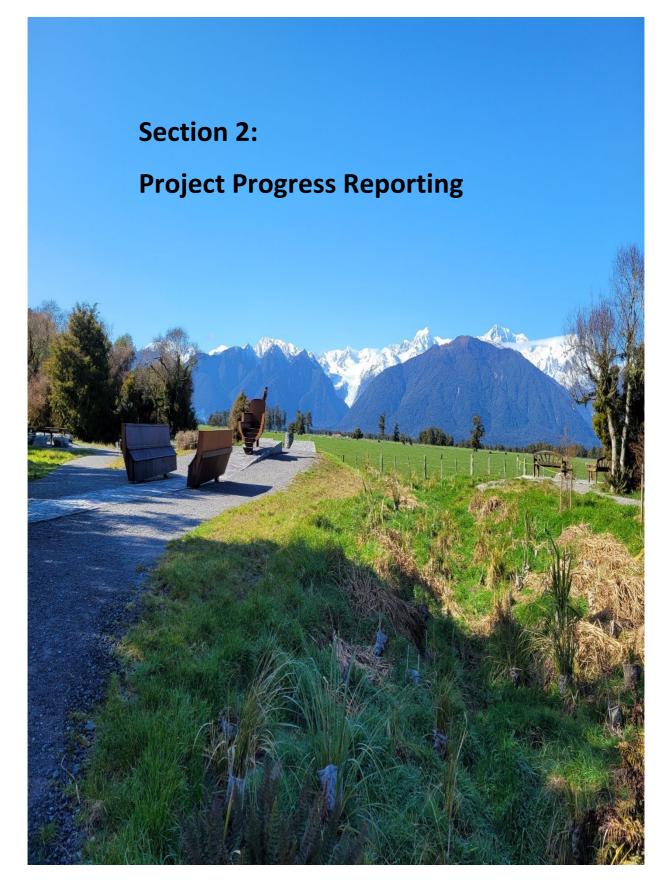

# Additional commentary on projects

# Freedom Camping Vehicle Register

On conclusion of the project, the remaining funding was reallocated to the Freedom Camping Implementation of Reforms project.

### Kākāpō Recovery Programme

All milestones with the exception of expansion to Five Fingers are expected to be delivered by the project end date. The population at Maungatautari has been reduced to three birds due to vegetation near the perimeter fence creating a high risk of escapes.

This project is tracking well against three key objectives, with the following highlights:

- Remote monitoring transmitter technology developed which will enable more efficient management (total 244 birds, population has doubled in last eight years).
- A new breeding site established at Te Kākahu-o-Tamatea/Chalky Island. Two additional sites are in early stages of suitability testing for kākāpō: Maungatautari and Pukahereka/Coal Island.

- Research continues on diseases of concern: Aspergillosis (following significant outbreak in 2019), and Highly Pathogenic Avian Influenza (vaccination trial underway).
- The next kākāpō breeding season is expected in 2026. New infrastructure is in place to support this. New breeding season management strategies have been developed to reduce management intensity while maintaining population growth.

# Ruapekapeka Pā

The last remaining part of this project is the installation of historic armaments for display. A new authority from Heritage New Zealand is required to construct a concrete plinth. Work on the cannon to be displayed has been completed, it will be stored until the display plinth is ready.

# Regulatory Compliance – Building Capacity and Capability for Conservation Law Enforcement

Three out of four benefits have been realised, with the fourth one partially realised (and to be continued through change request funding and BAU work programmes). The project is now in the closure phase, with a transition to BAU plan underway.

# Westland Destination Management Stage 1 - Fox Glacier

Increasing visitor numbers means the two projects that were paused are now needed and scheduled to be delivered in 2024/25. No extra funding will be required.

# <u>Hauraki Gulf</u>

Project stable, on track to realise benefits once legislation is enacted.

# Tongariro Alpine Crossing Sustainable Management Project

We have successfully completed the first year of implementation with most planned work delivered on time:

- A final booking solution is paused until year two to ensure we have a fit-for-purpose solution.
- Some cultural installations are still being delivered due to weather, production delays and prioritising the track start area.

# Information System Services Improvement Package

Geographic Information Systems upgrade could not be completed within the time period and is now being completed under a different funding stream.

# **Biodiversity Investment Approach project**

Tracking well, tools and process have been developed that are starting to support more informed investment decisions on DOC's biodiversity work.

# Lake Waikaremoana Great Walk Reopening, Visitor Experience Reimagining and Pest Control planning

The project is being delivered by Te Uru Taumatua (TUT):

- Lake Waikaremoana Great Walk was reopened 10 January 2024 following the Cyclone Gabrielle closures.
- Initial concepts for the reimagining of the visitor experience have been prepared and socialised with TUT and DOC staff and leadership.
- Pest control strategy has been approved and now moving into implementation planning.

# National Wilding Conifer Control Programme

With the IVL funding from DOC, the Ministry of Primary Industry's National Wilding Conifer Control Programme successfully coordinated delivery of an additional 143,900 hectares of wilding conifer control work on and around vulnerable areas of Public Conservation Land nationwide.

The injection of IVL funding reduced the areas due for maintenance by almost half, protecting conservation values and unique landscapes in those places and avoided the increased reinvasion and higher costs of delayed control.

# Cyclone Response – Biodiversity Priorities

Shore plover: Captive breeding and top up translocations to two islands and ongoing post-cyclone management completed. Further engagement required with iwi to progress translocation to a new island site.

Funding being held in reserve to accelerate breeding efforts to aid recovery of the fairy tern and shore plover in the 24/25 season.

### Te Manahuna Aoraki Project

This project is being delivered through partnership with the Te Manahuna Aoraki:

- The project continues to manage the elimination of possums, stoats and hares within the core area of the 18,200 hectares in the Malte Brun Range. Re-invasions are being managed in the buffer zone, particularly along the Murchison River flats. Spot treatment targeted areas where re-invading possums had been detected.
- Planning is underway to expand pest elimination in the Liebig Range.
