# Proposed Overseas Travel: Hon Judith Collins KC - April 2025

1 I seek Cabinet approval to travel Out of Scope

to Colorado, USA, from 8-12 April to attend the Space Symposium.

The Prime Minister has approved the travel in-principle, and House leave has been sought.

# **Purpose of Travel**

- 3 Out of Scope
- 4 In Colorado Springs, I plan on attending the Space Symposium, where I will:
  - 4.1 Focus on opening doors for our companies by supporting the participation of New Zealand space and advanced aerospace organisations, including through the exhibition hall booth; and
  - 4.2 Engage with the new senior US space officials as part of building relationships and advancing New Zealand's bilateral objectives regarding trade barriers.
- In Denver, on behalf of Minister Reti, I will attend the signing of a Memorandum of Cooperation with the Governor of Colorado. This will be a landmark moment for our SIT sector and will demonstrate that we are a global leader in geothermal research. It follows a commitment made with the Governor of Colorado during my visit to Colorado in April 2024 to develop a memorandum of understanding.
