### Purpose

---

To provide you with a suggested approach for announcing the release of funds from the Proceeds of Crime Fund to support initiatives to address crime and negative perceptions of safety in Auckland's central city.

## Background

---

1. On 19 February 2025, the Cabinet Social Outcomes Committee agreed to provide funding of \$1.352 million to address crime and negative perceptions of safety in the Auckland city centre. The funds will be provided from the Proceeds of Crime Fund (the Fund) [SOU-25-MIN-005 refers].
2. A new appropriation will be established under vote Police, with New Zealand Police (Police) administering the funds on behalf of central government. The funds will be provided to Auckland Council who will be responsible for disbursing them annually for three years to the Business Improvement Districts (BIDs) and the Local Board in the Waitematā Local Board Area.
3. Your Auckland officials will be responsible for providing you and the Associate Minister of Justice (Hon Nicole McKee) with reporting to demonstrate that funds have been spent on initiatives consistent with the objectives of the Fund.
4. Police are progressing a request to the Minister of Finance for an exemption from end-of-year performance reporting for the new appropriation under section 15D(2) of the Public Finance Act 1989.
5. Your application to the Fund was the last to progress under the previous process and criteria. Justice have advised that Mayor Brown is working with Police to initiate an application to the Fund to support additional Wardens across Auckland. That proposal will progress under the revised process and criteria and is currently awaiting the reopening of the Fund to new applications.

## Engagement with agencies

---

6. Your Auckland officials have worked closely with Police and the Ministry of Justice to access the Fund and Police are aware of its responsibilities to manage the funds on behalf of central government.
7. As noted above, the process for accessing the Fund has recently been amended and that process created some uncertainty around the process, assessment criteria and timeframe for consideration of your Auckland city centre proposal. Given this uncertainty, we have yet to engage with Auckland Council on its role in disbursement of funds to the local board and BIDs.

## Announcements

---

8. We understand that you intend to publicly announce the funding that you have secured from the PoCF for Auckland on Tuesday 18 March 2025 at the Auckland Policy Office. Talking points for the announcement are attached at **Annex One** and MBIE Communications are working with the Ministry of Justice and your office on a press release.
9. While the funding you have secured will be welcomed by Mayor Brown and Auckland Council, we recommend that you personally inform Mayor Brown of the details of your successful application prior to your public announcement. Once the Mayor has been informed, we will be in a position to work with Police to engage directly with Auckland Council, Waitematā Local Board and the relevant BIDs.

Delays in milestone payments for new trains, pavement renewals and property acquisition for the Eastern Busway were partially offset by the 2023 flood response being ahead of schedule.<br><br>Over the quarter, capital funding received was 44% from Auckland Council, and 56% from the NZTA and the Crown. Crown funding during this quarter included Crown Infrastructure Partners (CIP) |

funding for flood response work.

Auckland Transport reported on their performance during the quarter across their performance measures and deliverables set out in their Statement of Intent (SOI). Of the 23 performance measures in Auckland Transport's SOI, five were exceeded and 12 met over the quarter. One of the performance measures is Local Board satisfaction with engagement, which was at an all-time high of 71%.

Six measures were identified as not on track or not met, including:

- *Customer perceptions*: 'AT listens and responds' dropped four points to 27%.
- *Public Transport boardings*: these increased, but not as high as forecast. Target patronage for the financial year is 94.7m, with the number at the end of quarter two being 44.5m. Auckland Transport will need to average 10% year on year increases during the second half of the year to achieve the SOI target.
- *Public Transport Utilisation*: this measure looks at frequent routes during the peak. While some routes performed well at over 60% utilisation, others were below 30%.
- *Farebox Recovery Ratio*: reduced rail and bus patronage in December and delays to media revenue (such as on bus shelters) affected this.

For quarter two, 33 out of Auckland Transport's 40 SOI deliverables were reported as on track with four completed. The remaining three deliverables not on track are: delivering on Better, Faster Consents, and two related to growing external revenues (grow non-rates revenue and deliver cost saving and efficiency targets, and work to increase revenues from parking and enforcement).

### Public Transport Operating Costs and Farebox Recovery

Auckland Transport reported that public transport operating costs have increased from \$510 million in FY2019 to \$747 million in FY2024. These increases have varied by mode, as shown below.

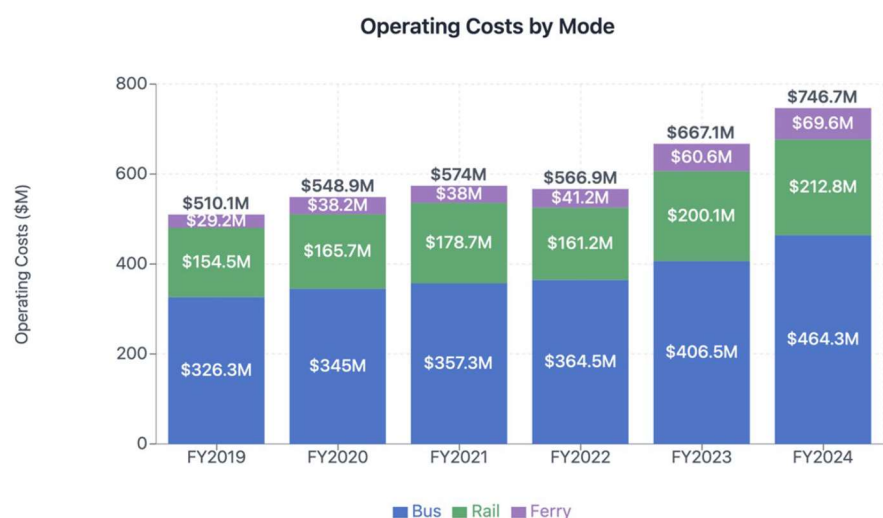

In part, the rail increases are due to the commencement of the Auckland One Rail contract in 2023, which includes facilities that were not part of the previous contract, as well as the increased track access charges. For ferry services, the Devonport contract was included from July 2022. For bus services, expanding the frequent transit network had an impact. All three modes were affected by high inflation.

The operating funding requirements per passenger journey have nearly doubled in this time, from \$3.27 in 2019 to \$6.30 in 2024. If Auckland Transport was dealing with 2024 costs but patronage was at 2019 levels, this would be \$5.55.

Ferry services had considerable variation between them, with inner-harbour ferries requiring significantly less subsidy than mid and outer harbour ferries.

The Committee held a closed workshop on the Public Transport Private Revenue Ratio (PRR), with some notes publicly shared alongside the TRIC agenda.

Although NZTA is no longer seeking the previously signalled PRRs, they do still expect to see improved PRRs over the next three years. Depending on the extent of these, options to achieve this could include:

- Reduction in bus services
- Reduction in ferry service
- Deferring Climate Action Transport Targeted Rate (CATTR) improvements
- Removing fare caps.

Additional options could include:

- Fare increases
- Advertising and sponsorship Commercial leasing
- Bus lane infringement revenue.

Auckland Transport's preferred option is to remain with the PRR based on 2024 LTP budget, which would be 30.2% in FY2026 and 30.5% in FY2027. The initial targets proposed by NZTA were 34% for FY2026 and 42% for FY2027.

Further hearings are scheduled for Monday 17 and Tuesday 18 March 2025. 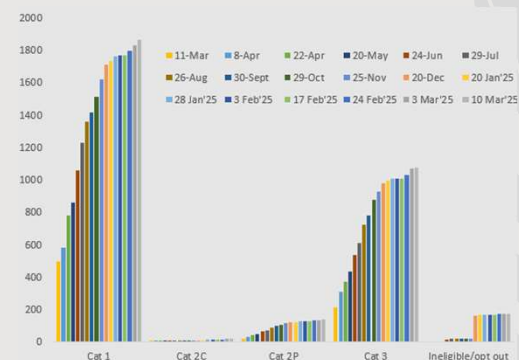

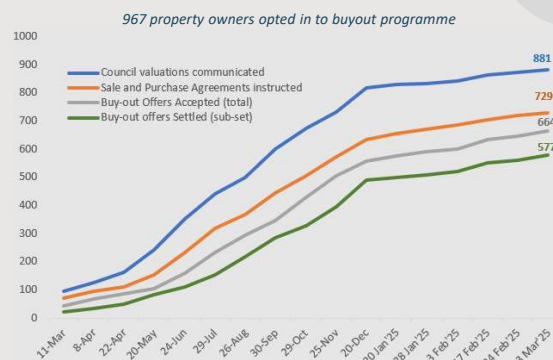

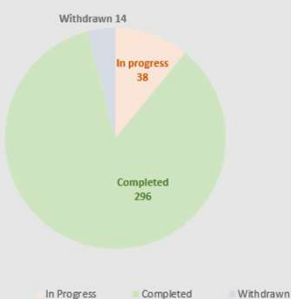

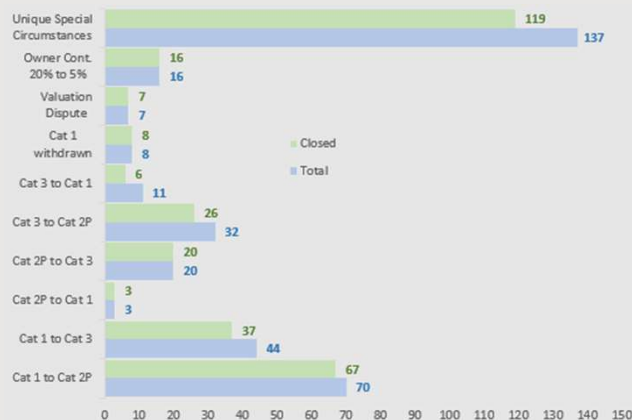

## Background

---

1. The Tāmaki Makaurau Business Network (the Network) was established to provide a unified voice for the Auckland business community into central government. The Network is convened by MBIE and meets regularly with Ministers and officials from other agencies to discuss initiatives that impact businesses across Auckland.
2. The Network is co-chaired by a business and central government representative. Viv Beck, Chief Executive of Heart of the City, is the business co-chair and Michael Quinn, Head of the APO, is the central government co-chair.
3. Membership includes chief executives and senior representatives from the Auckland Business Chamber, the Employers and Manufacturers Association (EMA), Whāriki, Pacific Business Trust, Hospitality NZ, Retail New Zealand, the Restaurant Association, Heart of the City and Tātaki Auckland Unlimited. Taken together, the associations represent the majority of businesses across the region.
4. The Network seeks to establish itself as a key source of business intelligence and sector advice for you as Minister for Auckland. You have agreed to meet quarterly with the Network with your most recent meeting taking place on 26 July 2024.
5. Short biographies of business members are included at **Annex One**.

## Meeting Format

---

6. The meeting will be held at the Auckland Policy Office on **Tuesday 18<sup>th</sup> March 8.20am to 8.50am**. The majority of attendees will join in person. Members know each other well and discussions are typically open and free flowing.
7. Simon Bridges is travelling overseas so is unable to attend. Josh Beddell will represent the Auckland Business Chamber.
8. The Network have met to discuss topics of interest to members and these are reflected in the agenda attached at **Annex Two** and suggested talking points attached at **Annex Three**.
9. High level notes on each item are included below.

### Introductory remarks

10. Your introductory remarks are an opportunity for you to acknowledge the significance of Auckland for the national economy and the importance of the city's business leaders in delivering economic growth. While the last few years have been undoubtably tough for Auckland businesses, there are grounds for optimism, with economic headwinds abating and significant infrastructure investments such as the City Rail Link and the International Convention Centre closer to fruition.
11. You may wish to remind the Network of your role as both an advocate for Auckland in Cabinet as well as coordinating government initiatives and investment in the city.

### Specific topic areas

#### *Economic Growth*

12. The Network has welcomed the recent announcement of the Coalition Government's focus on Economic Growth. Consistent with the Network's Auckland focus, discussion will likely emphasise the contribution of Auckland to the economy and the importance of ensuring it is central to the national economic growth narrative.

13. Members will be interested to discuss how the businesses that they collectively represent can support economic growth and how government and business can work together to unlock economic growth opportunities in Auckland.

#### *Law and Order*

14. Crime and negative perceptions of safety in Auckland were discussed at your previous meeting with the Network and continue to be areas of concern. You will be aware that Viv Beck holds strong views and was instrumental in the establishment of the City Centre Safety Hubs. She has also advocated strongly for a stronger Police presence in the central city including additional beat Police and a central Police station – both of which have been recently announced.
15. Network members are engaged with the various initiatives currently underway, including those led by Police and the Ministry of Social Development. They will advocate for a focus not just on action to ensure their members are protected from criminal activity (e.g. retail crime), but also for measures to ensure that the wider community feels safe to engage in activities across the city (e.g. attending events). Existing perceptions that areas of the city are unsafe to visit is having a significant impact on service sectors such as retail and hospitality.
16. We understand that later the day of this meeting, you will publicly announce that you have been successful in securing funding the Proceeds of Crime Fund to support initiatives delivered by the Local Board and Business Improvement Districts (BIDs) to address crime and negative perceptions of safety in central Auckland. You may wish to inform the Network of this development, in confidence ahead of that announcement. We note that Viv Beck is CEO of Heart of the City, which is one of the BIDs that will receive funding. It would be appropriate for her to be given a heads up prior to informing the Network.

#### *Transport*

17. The Network agree that an inefficient transport network is a drag on productivity and will likely express support for the Time of Use charging Bill.
18. The Network considers that understanding the impact on the business community is essential, including the risk of Time of Use Charging on the central city fringe impacting access to the city centre. The Network will emphasise its diverse membership (from big corporates to sole operators) and offer to assist you and your officials to understand the Auckland business perspective.
19. They are also interested in an update on transport governance reforms and CRL, including level crossings.

#### Closing remarks

20. As noted, the Network seeks a more active role, as the voice of the Auckland business community, in supporting you. The breadth of membership (size, sector, national connections etc.) and the commitment of the Network to constructive engagement as a collective with central government over a number of years, suggests that there is value in ongoing engagement.
21. You have agreed to meet quarterly, although the date of the next meeting has yet to be confirmed.

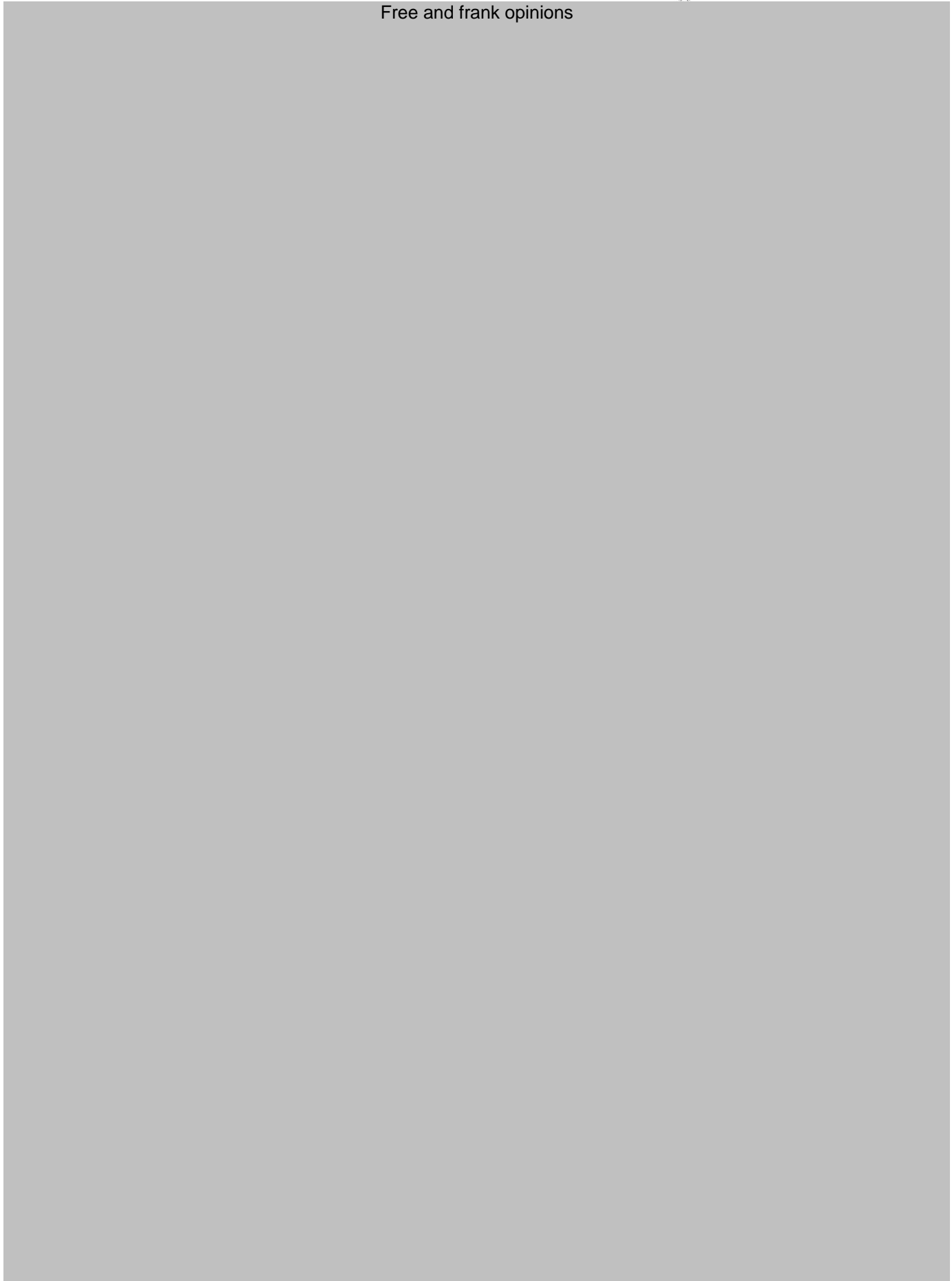

### Purpose

To seek your feedback on the membership of a regular series of meetings with Auckland-based officials to assist with your Auckland ministerial portfolio responsibilities.

### Executive summary

Following your request, we propose establishing a regular forum for engagement with Auckland-based government officials. This will provide direct and timely access to information on Auckland issues, supporting your coordination and advocacy role.

We recommend a monthly hybrid meeting given the complexities of coordinating diaries, with in-person attendance preferred when you are available in Auckland. Membership would be aligned to your six focus areas: regional deal; recovery; transport; law and order; water; and economic growth. Membership is flexible and can be expanded if new issues or priority areas emerge.

Most attendees will be Tier 3 to Tier 5 officials as senior leadership is primarily Wellington-based. Therefore, there might be limitations in participants broader awareness of their agency's involvement in programmes. This can be mitigated by having a clear agenda beforehand so that participants can come prepared. MBIE will manage all pre-meeting preparations.

A list of recommended agencies is attached (Annex A), along with a broader list of agencies present in Auckland (Annex B) for your consideration. To support information sharing, Carolyn Tremain will engage with her chief executive colleagues on the establishment of the forum.

As next steps, we require you to confirm:

- i. Your preference for regular meetings with Auckland-based officials.
- ii. The agencies you wish to include.
- iii. The preferred meeting frequency.
- iv. A start date for the meetings.

Once confirmed, we will set up the meetings, invite attendees and prepare a draft agenda.

## Background

---

1. The Employers and Manufacturers Association (EMA) is New Zealand's largest business association. Established in 1886, the EMA provides business services to over 76,000 member companies located across Northland, Auckland, Waikato and the Bay of Plenty.
2. Business services the EMA provides to its members includes Advocacy Services, Exporting Services, Membership Rewards, Member Briefings, Conferences and Events, Manufacturing Services, Training & Development, Legal Services and Consulting, Advice Line and Advisory Support, and access to Members Only Resources. It also provides members with free employment advice, quarterly market briefings, law guides, advice on export opportunities and targeted business training.
3. While the EMA membership is constrained to the top half of the North Island, it has a national reach through its longstanding association with a national network that includes Business NZ, Business Central, Business Canterbury and Business South.

## Meeting Format

---

4. The meeting will be held at the Auckland Policy Office on **Tuesday 18<sup>th</sup> March 8.50am to 9.20am**. The EMA will be represented by John Fraser-Mackenzie and Alan McDonald. Brief biographies are attached at **Annex One**.
5. This meeting immediately follows your meeting with the Tāmaki Makaurau Business Network (the Network). The EMA is a member of the Network and John and Alan will attend both meetings. As such they will have heard your introductory remarks and discussion on issues of interest to the Network.
6. The EMA have indicated that they would like to provide you with an update from businesses on the opportunities and challenges facing its membership. Specific topic areas they will raise are outlined below. Suggested brief talking points on these items are attached at **Annex Two**.

### Specific topic areas

#### *Regional Deals*

7. The EMA is interested in progress on Regional Deals - primarily Auckland but Northland, Waikato and Bay of Plenty also fall within their areas of operation.

#### *Public transport and time of use charging*

8. The EMA consider that the introduction of time of use charging will result in increased usage of public transport. They will likely raise concerns about the need for additional funding to provide adequate public transport options alongside the introduction of time of use charging.

#### *Electricity Pricing*

9. The EMA are concerned with the ongoing impacts of electricity pricing and the prospect of higher prices and winter shortages again this winter. This impacts their members, especially for manufacturers in Northland and Auckland. They would like to hear about decision-making on renewable energy infrastructure and new generation projects.

#### *Health*

10. The EMA would like to hear an update about the progress of Whangarei Hospital rebuild/refresh and the role that government and private providers can play in clearing surgical waiting lists. The EMA membership includes major private health providers.

### *Extension of Citizen's Arrest powers*

11. The EMA strongly oppose the extension to the Citizen's Arrest powers. They think it creates high levels of risks and has significant ramifications for employers under health and safety regulations, if employees seek to utilise the new powers.

There has been significant public and media interest on this item.</p> <p><b>Council's decisions on the feasibility studies/next steps</b></p> <p>Council noted that neither proponent has demonstrated that their proposal is feasible without significant public funding; that Eden Park 2.1 is technically feasible, but is not currently financially feasible because it relies on significant public funding; Eden Park 2.1 can be progressed in stages and there may be merit in progressing the case for Government support for early stages; Te Tōangaroa had not demonstrated that their proposal is technically or commercially feasible at this stage and has suggested it needs more time to do so. Council also received the review of the current state of the network, which notes the status quo is that Eden Park is the region's largest nationally significant stadium and notes several challenges affecting the stadium network.</p> <p>The Council also endorsed, in principle, a staged redevelopment of Eden Park as the best and most feasible option for providing Auckland with a fit-for-purpose main stadium in the future, subject to:</p> |

- completion of a business case for Stage 1 (at Eden Park's own cost) that establishes a robust case for Government support and confirmation of Central Government support (noting there are no plans for Council to provide funding towards Eden Park's redevelopment);
- all parties working together to satisfactorily address challenges with the status quo (including Eden Park's financial obligations to Council, and ensuring funding, ownership structure and governance arrangements based on returning the best public value for Auckland and New Zealand).

Council also requested that the Auckland Council Chief Executive engage with Eden Park and the Government to constructively address challenges with the status quo and enable adequate consideration of Eden Park's development plans based on returning the best public value for Auckland and New Zealand and bring any recommendations back to Governing Body.

### **Background to the feasibility studies decision**

In recent years, Council has received several unsolicited proposals from third parties about developing a 'main stadium' at little or no additional cost to ratepayers. The Eden Park Trust Board has also expressed a desire to progress significant upgrades of its facility. There were, and still are, no plans for Council to provide funding towards a new stadium or significant upgrades to existing stadiums. However, the unsolicited interest from multiple parties required a structured process to manage expectations and resources. Based on the Mayor's recommendations, a formalised Expression of Interest (EOI) process was established under the political oversight of a Working Group and an open Request for Expressions of Interest (REOI) was published seeking options to deliver a main stadium at little to no cost to ratepayers.

The Governing Body resolved to invite the proponents of Eden Park 2.1 (Eden Park Trust) and Te Tōangaroa/Quay Park (Te Tōangaroa Consortium) to undertake, at their own cost, feasibility studies to demonstrate their project's deliverability and relative merit. Council assessed the status quo and coordinated the feasibility work. The meeting will consider these proposals. Eden Park 2.1 proposes a phased redevelopment to enhance functionality and capacity, including retractable seating, a retractable roof to improve venue versatility with precinct development and transport connectivity improvements to the Kingsland CRL station to improve transport access. The Te Tōangaroa proposal integrates a multi-purpose stadium with the development of the surrounding Quay Street precinct.

### Auckland Economic Update March 2025

Auckland Council has published its monthly economic update for Auckland. The full report is attached at **Annex Two**.

Highlights this month include:

- **median house price** for the month of January 2025 was \$949,000 (in real\* dollars: similar to nine years ago (2015/2016); 4% lower than a year ago; 6% below December (\$1.01 million); 37% below the 2021 peak);
- **number of houses sold** for the year ended January 2025 was 21,977: 20% above the May 2023 trough, and rising continuously since September 2024, but still 40% below the July 2021 peak.



- **average weekly rent** for the month of December 2024 was \$690 (in real\* dollars: broadly similar to the last several months, e.g. 1% lower than a year ago; below most of the last eight years). For the rest of New Zealand, the figure was \$599: rising due to seasonality; similar to a year ago, following over three years of minimal increases.
- **number of new dwellings consented** in the year ended January 2025 was 13,921: 37% lower than the September 2022 peak; 7% below the 2019/2020 pre-Covid peak five years ago; rising slowly since July 2024.
- **real\* value of new non-residential buildings consented** in the year ended January 2025 was \$2,487 million: 17% below a year earlier; below nearly all of the last four years, and 28% below the November 2022 peak, but 10% above the 2020 trough.
- **number of people employed** in the quarter ended December 2024 was 2.0% lower than in December 2023 quarter: the sixth quarter in a row of falling annual growth rates despite population growth.
- **unemployment rate** in the quarter ended December 2024 was 5.3%: the highest-equal quarter since the 2020 Covid lockdowns, and above most of 2017 to 2024, but still lower than 2009 to 2015 and late 2020.
- **real\* value of GDP** for the year ended December 2024 was 0.6% lower than for the year ended December 2023; in the rest of New Zealand, the annual change was 0.4% fall (see notes). Both growth rates were: below most periods since 2010; falling since mid-2023; lower than recent population growth; nearly as low as the Covid-related trough of 2020; above the GFC-related trough of 2009.
- **real\* value of retail sales** for the year ended December 2024 were 4.3% lower than for the year ended December 2023; in the rest of New Zealand, the annual change was a 3.1% fall. Both growth rates were among the lowest since 2009 (just after the Global Financial Crisis), even including the 2020 Covid lockdowns. Both growth rates have been generally falling since late 2022.
- **real\* value of imports by Auckland seaports** for the year ended January 2025 was \$30.0 billion, which was 3% lower than the year ended January 2024, but 15% higher than the 2020 Covid trough. For the rest of New Zealand, the figure was \$30.5 billion: 6% lower than a year ago, and 25% lower than the 2023 post-Covid rebound peak. For most of 2024, import values for Auckland and the rest of New Zealand were similar, and both showed a slight downtrend.

\*real dollars/values are after adjusting for the effects of inflation each quarter, so a similar 'real' level means that a value rose at a similar rate to inflation.

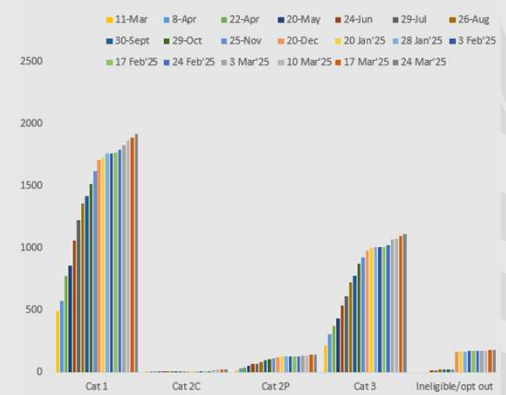

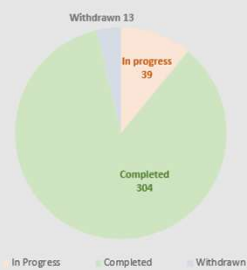

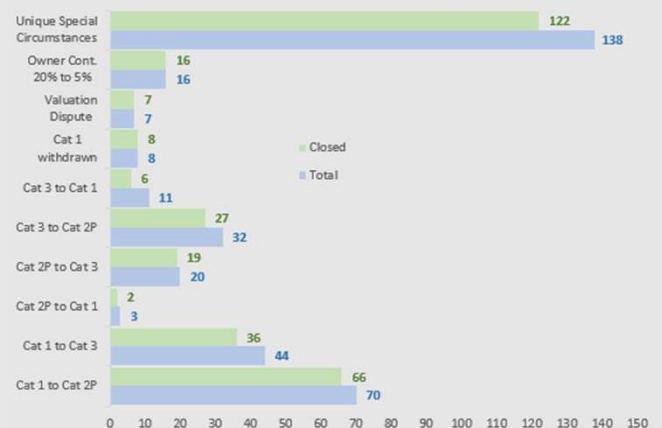

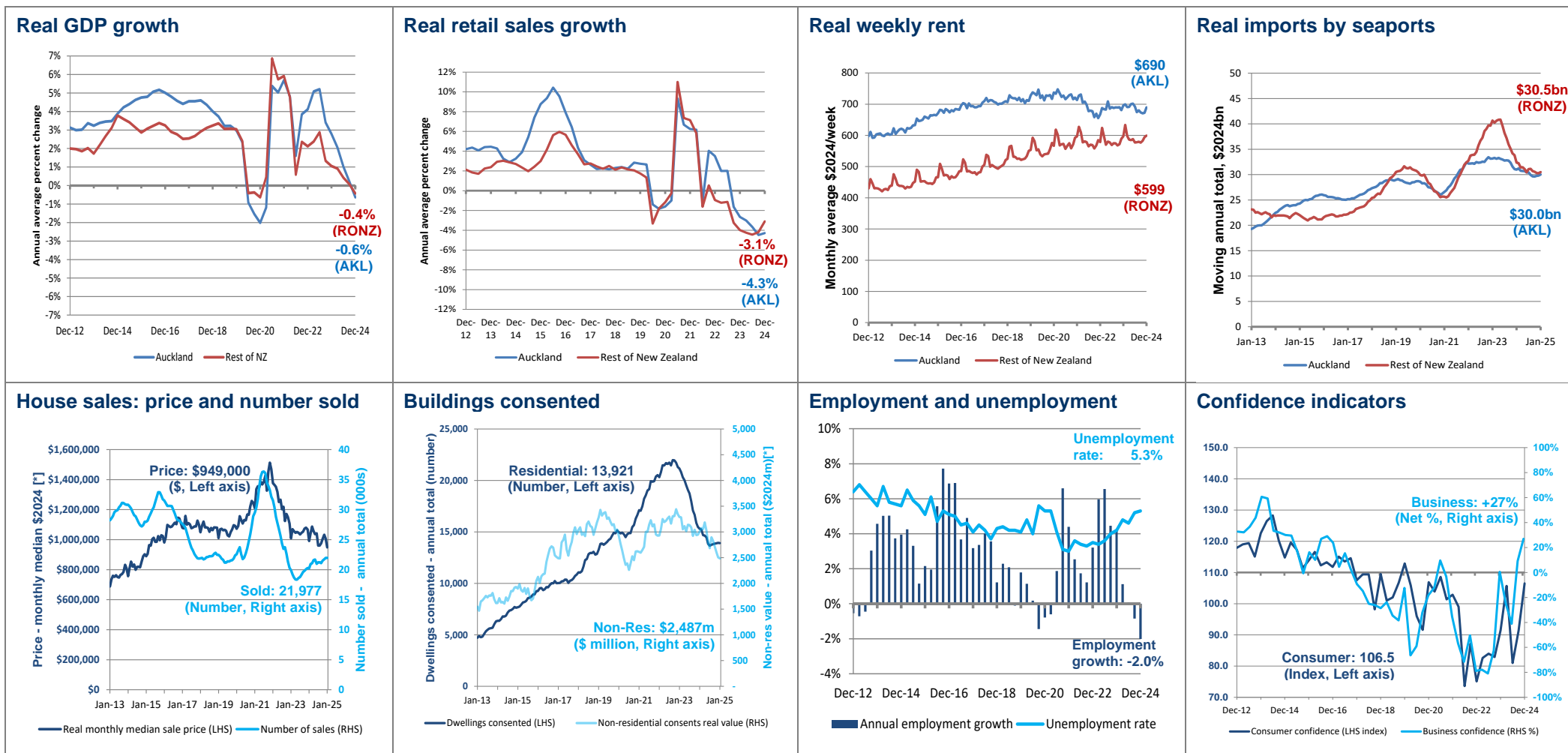
Monthly – total vs open and closed cases

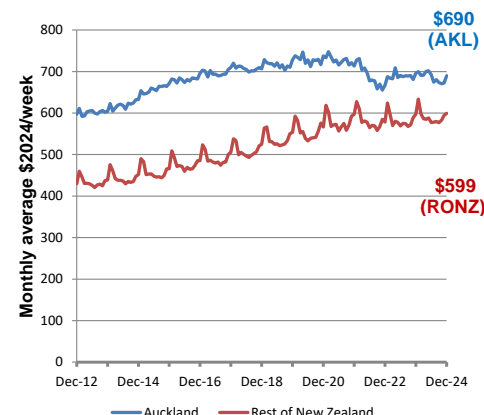

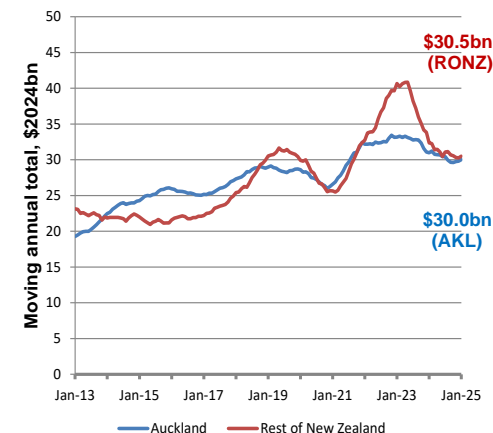

Both growth rates were: below most periods since 2010; falling since mid-2023; lower than recent population growth; nearly as low as the Covid-related trough of 2020; above the GFC-related trough of 2009.

Real\* retail sales for the year ended December 2024 were 4.3% lower than for the year ended December 2023; in the rest of New Zealand, the annual change was a 3.1% fall. Both growth rates were among the lowest since 2009 (just after the Global Financial Crisis), even including the 2020 Covid lockdowns. Both growth rates have been falling since late 2022, although the rate for rest of New Zealand recovered slightly in late 2024.

The average weekly rent for the month of December 2024 was \$690 (in real\* dollars: broadly similar to the last several months, e.g. 1% lower than a year ago; below most of the last eight years). For the rest of New Zealand, the figure was \$599: rising due to seasonality; similar to a year ago, following over three years of minimal increases. "Real rent" changes are relative to CPI inflation, so a similar "real" level means rents rose at a similar rate to inflation.

The real\* value of imports by Auckland seaports for the year ended January 2025 was \$30.0 billion, which was 3% lower than the year ended January 2024, but 15% higher than the 2020 Covid trough. For the rest of New Zealand, the figure was \$30.5 billion: 6% lower than a year ago, and 25% lower than the 2023 post-Covid rebound peak. For most of 2024, import values for Auckland and the rest of New Zealand were similar, and both showed a slight downtrend.

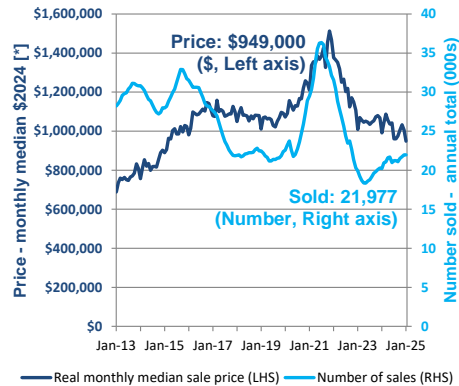

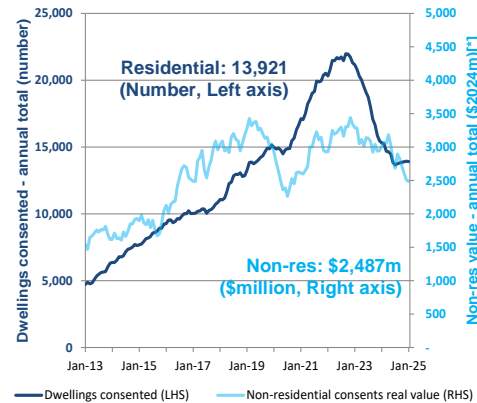

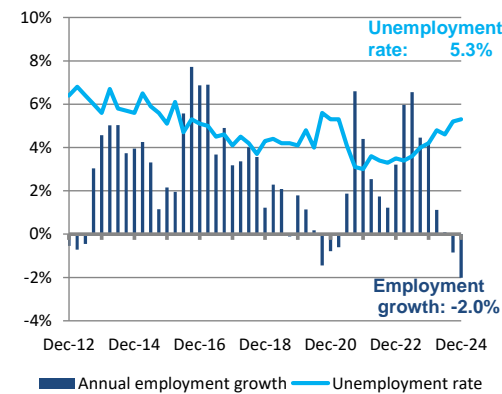

The number of people employed in Auckland in the quarter ended December 2024 was 2.0% lower than in December 2023 quarter: the sixth quarter in a row of falling annual growth rates despite population growth.

The unemployment rate in Auckland in the quarter ended December 2024 was 5.3%: the highest-equal quarter since the 2020 Covid lockdowns, and above most of 2017 to 2024, but still lower than 2009 to 2015 and late 2020.

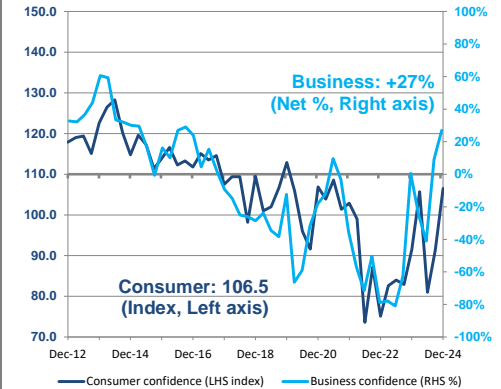
Note: Covid-19 lockdowns began on 23 March 2020, plus wage subsidies, which both affect official unemployment.

Employment data is rebased by Stats NZ each quarter to match latest revisions of historic population estimates.

Both datasets are from a survey (HLFS) so are subject to error margins. Respondents define their own employment status. The survey covers all people aged 15+, so includes school pupils 15+ and people over 65, who might or might not have - or be actively seeking - a job.

## Confidence indicators



In Auckland, the Westpac McDermott Miller Consumer Confidence Index (CCI) for the December 2024 quarter was 106.5: the highest-equal since 2021, but below 2013 to 2018.

The NZIER QSBO in Auckland for the December 2024 quarter showed a net 27% of businesses expecting the general business situation to improve over the next three months – the highest quarter since 2016, and the highest December since 2014.

Note: Left axis is for CCI (consumers: index). For the CCI, a score of greater than 100 shows more optimism than pessimism. Re-scaled 18/9/2024.

Right axis is for QSBO (businesses: net %). The QSBO calculates a net figure as (% of businesses expecting an improvement) minus (% expecting a worsening). QSBO data used here is not the seasonally adjusted version.
