## SUMMARY LIST OF ACTIONS

- 1.1 Strengthen board monitoring and oversight of strategy implementation, including:
  - a. Monthly reporting on the achievement of revenue growth and revenue diversification, opportunity pipeline and contracting rate
  - b. Monthly reporting of tangible progress in the seven priority growth initiatives that resulted from the strategy review.
- 1.2 Increase reporting detail of revenue and revenue growth in Quarterly Reports to the Shareholder, with effect from Q1 2013/14.
- 1.3 Complete the resource management component of the Plant & Food Research Simplification project by 31 December 2013 as a key enabler for achievement of Business Plan productivity targets (growth in revenue with no overall increase in staffing numbers).
- 1.4 Implement capital redevelopment projects that deliver planned productivity improvements and that are necessary for continued revenue generating operations. Phase expenditure commitments to mitigate risk, as outlined in the Business Plan.
- 1.5 Complete an asset strategy review approved by the Plant & Food Research Board by 30 November 2013 which, inter alia, addresses:
  - a. Required locations and facilities, ownership, divestment
  - b. Collaboration opportunities at Mt Albert, Palmerston North and Lincoln sites to share capital and operating costs and increase asset utilisation
  - c. Options to accelerate sales of non-strategic land and other assets.
- 1.6 Formally report to and discuss at least annually with the Shareholder options for debt and/or dividends to be advanced relative to the commitments in the Business Plan, should financial performance be more favourable or improve earlier than projected in the Business Plan.
- 2.1 Complete the strategy refresh for Māori, approved by the Plant & Food Research Board by 31 December 2013.
- 2.2 Hold a workshop on our Māori strategy and activities with MBIE officials and other stakeholders by 31 December 2013.
- 2.3 Deliver and report on the approved KPIs in 2013/14.
- 2.4 Enhance the reporting capability of our research investment portfolio database to provide better visibility of all research activities that directly benefit Māori, by 31 March 2014.

- 3.1 Review Plant & Food Research strategy for food, for Board approval by 31 December 2013, addressing inter alia:
  - a. The role for Plant & Food Research to provide leadership for growth of the food and beverage sector
  - b. Whole foods and processed foods and beverages
  - c. Opportunities in health and nutrition
  - d. Participation in New Zealand's food and beverage innovation networks to enhance industry engagement and supply and access relevant capability
  - e. Research partnerships and in-house capability
  - f. International opportunities in food and beverage research that add to Plant & Food Research's delivery of its Core Purpose (for example by creating commercial opportunities for New Zealand food exporters).
- 3.2 National Science Challenges
  - a. Contribute to NSC process including assisting working groups undertaking development and planning of each challenges (already underway)
  - b. Finalise areas for Plant & Food Research involvement once research programmes for the Challenges are finalised
  - c. In parallel, review and if necessary update or develop new partnerships that provide the required multi-disciplinary research capabilities for the NSC programmes.
- 4.1.1 Suggest MBIE consider, if changes to Statements of Core Purpose are envisaged, moving bio-materials from the section of the Statement of Core Purpose which states:

"Plant & Food Research is the lead CRI in the following areas"
