Background

- 1. This briefing follows on from *Options for Budget 2025 for New Zealand Trade and Enterprise* provided to you last week [BRIEFING-REQ0007117 refers]. You agreed to two options in that briefing, including:
 - a. the reallocation of \$11.15 million per annum from NZTE to Invest NZ for the investment functions (including the \$1.204 million annual appropriation for the Strategic Investment Fund), and
 - b. making changes to the International Growth Fund to sharpen its focus on performance and impact and reduce the size of the fund to make total savings of \$6 million across 2024/25 and 2025/26 only.
- 2. A letter to the Minister of Finance, summarising the Budget 2025 submission for the Economic Development portfolio, is included as **Annex One**.
- 3. The Minister of Finance has requested that the Minister for Economic Development work with the Minister for Trade and the Minister of Science, Innovation and Technology on these initiatives. We recommend that you forward this briefing to the Minister of Science, Innovation and Technology for her noting.

Letter to the Minister of Finance

- 4. The draft letter outlines that you have considered a range of options for New Zealand Trade and Enterprise, the International Growth Fund and the Strategic Investment Fund. It highlights the importance of considering the impact of any savings options considering Cabinet's agreements to:
 - a. refocus New Zealand Trade and Enterprise's work to prioritise strong export outcomes; and
 - b. focus on growing the economy and double exports in the next ten years.
- 5. By following these objectives, the approach to the International Growth Fund and the Strategic Investment Fund proposed in the letter does not generate savings in the order suggested in the Minister of Finance's Budget 2025 letter.

Next steps

- 6. All MBIE-related initiatives, including those related to New Zealand Trade and Enterprise, are due to the MBIE central Budget team for submission to the Treasury on 17 December 2024.
- 7. The letter to the Minister of Finance needs to be submitted by 1pm, 23 December 2024.
