#### Proposed Overseas Travel: Hon Erica Stanford - September 2025

#### **Proposal**

- 1. I seek approval from Cabinet to travel to the United States of America from 15 21 September in my capacity as Minister of Immigration.
- 2. I will travel to New York, Los Angeles and San Francisco to lead a delegation of immigration and investment private sector participants to promote our Active Investor Plus visa. Since it was implemented on 1 April 2025 this visa has generated significant new proposed investment in New Zealand of over \$1b with US investors submitting the most applications.
- 3. The Prime Minister has approved the travel in-principle and leave of the House has been approved.

#### Purpose of travel

- 4. If approved, I will:
  - Attend events in New York, Los Angeles and San Francisco hosted by Invest
     NZ to promote the Active Investor Visa; and
  - b. Meet with potential investors as organised by Invest NZ and/or members of the accompanying delegation.

### **Ministerial Party**

5. I will be accompanied by my Specialist Ministerial Advisor as part of the Ministerial Delegation. Travel costs of the Ministerial party will be a charge to Vote Internal Affairs: Members of the Executive – Travel.
