1. Portfolio Update

1.1 Regional Economic Roundup Report

Westpac recently released their April 2025 Regional Roundup which summarises the outlook for New Zealand regions. The report outlines that economic conditions remain cool across the country, although the economic outlook appears to be looking slightly brighter.

General sentiment from businesses notes:

- demand remains subdued, particularly in parts of the retail, hospitality and construction sectors
- growing optimism that economic conditions are likely to improve, largely influenced by the easing in borrowing costs.

Regionally, economic conditions are uneven across the country. Canterbury, Otago and Southland are outlined as the strongest performing parts of the country. Improving prices for dairy and other key commodity exports are boosting incomes, sentiment and spending. The ongoing recovery in international visitor numbers has also supported spending in areas like Queenstown. This assessment is in line with the March 2025 ASB Regional Economic Scoreboard.

In the major urban centres, particularly Auckland and Wellington, businesses continue to report tough trading conditions. Wellington is not seeing the same benefits from recovering commodity prices that are being seen in many rural areas, nor is it benefiting from the lift in international visitors in the same way as centres like Queenstown and Auckland.

The following table summarises regional economic conditions outlined in the report using the following scale: Frosty - Cold - Cool - Mild - Warm - Hot. **Annex two** provides further regional information from the report.

1.2 Statistics New Zealand Regional Census Infographics

Cory Hagenaars, South Island Lead Advisor Statistics New Zealand (Stats NZ) have released detailed regional infographics with data derived from the 2023 Census. These infographics provide insights into the South Island's demographic, economic, and social trends. The information contained is compared with data from the 2018 Census.

Key points for South Island regions are:

- Southland had the highest increase in median rent (50.4 per cent).
- Nelson had the highest increase to median income (30.9 per cent).
- Canterbury had the largest increase in population (8.6 per cent).
- Tasman had the highest rate of home ownership (77.4 per cent).
- West Coast had the highest reports of homes that are damp at least once (20.2 per cent), however, the remainder of South Island regions reported lower levels comparatively (under 15 per cent).



On Tuesday 2 April 2025, Stats NZ released data on building consents issued for the year ending February 2025 (https://www.stats.govt.nz/information-releases/building-consents-issued-february-2025/). Building consents are a good indicator of building activity and construction industry performance. Consenting activity in the South Island indicated that the residential building sector was more resilient to the post-pandemic economic downturn compared to the North Island.

In the year ending February 2025, the South Island had a total of 10,360 new residential building consents issued. This was a 3 per cent increase on the previous year, but an 18 per cent decrease from its peak in the year ending February 2023. The North Island in comparison was down 11 per cent in the previous year and down 35 per cent in the year ending February 2023.

While the consent number trend for houses in the South Island has shown some early indication of bottoming out, the trend for multi-unit homes was still weak. By comparison, the number of standalone homes consented nationally follows a similar trend, while the number of multi-unit homes consented nationally saw growth year-on-year between 2015-2023 and has exceeded the number of standalone homes consented since 2022.
