Visit to Independent Fisheries Limited

- 1. On Monday, 5 May 2025, you will visit Independent Fisheries Limited (IFL) at 15 Dublin Street, Lyttleton, Christchurch, at 10.00am. You will be met on arrival by the IFL management team and Clayton Cosgrove.
- 2. As part of the visit, you will be given a tour of one of their fishing vessels to view their operations. Following this, you will travel (approximately 10 minutes drive) to IFL's Cool Store at 4 Broad Street, Woolston for a tour of the facility and to meet staff. You will finish the tour by 11.30am.

Background of Independent Fisheries Limited

- 3. IFL is an aquaculture company that employs around 500 staff and is focused on fish harvesting, processing, freezing, packing, and storage.
- 4. IFL operates three large (over 100 metres in length) deepwater trawl vessels, each crewed by up to 80 crew members. All three vessels operate almost exclusively out of Lyttleton Port. Two of these (the *Irvinga* and the *Independent*) are owned by Sealord Group, while one (the *Mainstream*) is a chartered vessel. IFL also operates a large cool storage facility in Woolston.
- 5. IFL business activities has led to employment in a range of associated industries such as fuel suppliers, port services, engineering, and transportation. The three vessels also utilise Lyttleton Port for specialist services such as surveying, marine engineering, and dry dock facilities.
- 6. IFL's vessels primarily fish for five deepwater species: hoki, jack mackerel, southern blue whiting, barracouta, and arrow squid.
- 7. Their processed seafoods product range includes skinned southern blue whiting fillets, tempura whiting fillets, smoked hoki fillets, hoki loins, and crumbed whiting goujons.
- 8. Along with supplying the domestic market, IFL exports primarily to Australia, but also to China, Japan, South Africa and Eastern Europe.
- 9. IFL's annual reports are no longer publicly available as it is now a subsidiary of Sealord.
- 10. IFL was founded by Howard Shadbolt in 1956 and was originally a fish and chip shop in the Christchurch suburb of Linwood. IFL then went on to become one of the largest fishing businesses in New Zealand.
- 11. In February 2024, following clearance from the Commerce Commission and consent from the Overseas Investment Office, Sealord Group Limited acquired IFL, making Sealord Group Limited New Zealand's largest seafood business. The sale included 46,000 tonnes of deepsea fishing quota, fishing vessels, and cold store assets.

Background of New Zealand Aquaculture Sector

12. New Zealand's Exclusive Economic Zone (EEZ), the area of the ocean that New Zealand has special rights regarding the exploration and exploitation of its marine resources, covers approximately four million square kilometres. This is approximately 15 times the size of New Zealand's land mass and the 5th largest in the world. The EEZ provides New Zealand with bountiful aquacultural resources, allowing New Zealand to play a significant role in the global seafood industry.

- 13. In 2022, New Zealand's Aquaculture sector created direct economic contribution of \$818.00 million and a total economic contribution of \$2.20 billion, representing 0.7 per cent of New Zealand Gross Domestic Product¹.
- 14. The New Zealand Aquaculture sector also employed 6,314 full time equivalents (FTEs) and led to total employment of 16,522 FTEs, representing 0.7 per cent of New Zealand employment in 2022¹.
