1.2 Social Investment Fund Announcement

Cory Hagenaars, South Island Lead Advisor On 15 May 2025, the Government announced the establishment of a new \$190.0 million Social Investment Fund as the centrepiece of its \$275.0 million Social Investment Budget package. This initiative aims to transform the delivery of social services by focusing on early, evidence-based interventions to improve outcomes for vulnerable New Zealanders.

Key components of the Social Investment Fund:

- The total funding package is \$275.0 million over four years, with \$190.0 million dedicated to the Social Investment Fund.
- The objective is to invest in programmes that deliver measurable improvements to the lives of children, young people, and families in need.
- The fund will be managed by the reinstated Social Investment Agency (SIA). The SIA
 was disestablished in March 2020 by the previous government, and was reinstated
 in July 2024 by the current government. The SIA will work in partnership with
 community organisations, non-government agencies, and Iwi providers to deliver
 the fund.

Specific initiatives include:

- Parenting support: \$20.0 million allocated to programmes that strengthen
 parenting in the first 2,000 days of a child's life, aiming to reduce harm and set
 children up for better long-term outcomes.
- Prevention of entry into state care: \$25.0 million dedicated to initiatives that help prevent children and vulnerable adults from entering state care. This is part of the Crown's response to the Royal Commission of Inquiry into Abuse in Care.
- Community-based programs: funding for programs such as Emerge Aotearoa's work with at-risk youth and the He Piringa Whare program, which provides wrap-around services including stable housing, education, and employment support.

While specific allocations for the South Island have not been detailed, the Fund's nationwide scope means that communities across the South Island's regions are eligible to benefit from these investments. Local service providers and community organisations in the South Island can engage with the Social Investment Agency to develop and propose initiatives aligned with the Fund's objectives.

Workforce/employment update

Statistics NZ have released <u>labour market statistics for the March 2025 quarter</u>. The results show a generally stronger labour market in the South Island compared to the North Island.

- In the year to March, total employment increased by around 11,000 people in the South Island (up 1.6 per cent) but fell by 32,000 people in the North Island (down 1.5 per cent).
- While the North Island's unemployment rate has increased from 4.8 per cent to 5.8 per cent over the year, the South Island's unemployment rate has remained unchanged at 4.2 per cent over the same period.
- The South Island's annual employment growth was concentrated in Otago, which now also has the lowest unemployment rate in the country (2.6 per cent, compared to the national rate of 5.1 per cent). Underpinning growth in this region is the strengthening primary sector, and recovery in international tourism. Otago, unlike other regions, has also seen growth in residential building consents over the year which is supporting the construction sector.

Tourism sector update

MBIE's Tourism Electronic Card Transactions data for year-end March 2025 showed a softer South Island tourism sector than year-end March 2024. This was largely due to the timing of the Easter break this year, which shifted domestic tourism into April instead.

- Total tourism spend was down -1.9 per cent (-\$96.6 million) on March 2024, however international tourist spend was up 6.3 per cent (\$95.1 million).
- Visitor arrivals from Australia was up 8 per cent, and from China up 18 per cent year-on-year.
