- The Minister of Finance wrote to you on 9 December 2024, requesting that you provide three reprioritisation and savings packages that equate to Confidential advice to Government as part of your Budget submissions.
- 2. As discussed with you on 4 December 2024, we have been working on a set of transfers within existing SI&T appropriations to enable the agreed system reforms to be funded, by repurposing funding in lower priority areas. This is consistent with your proposal agreed by Cabinet that you will implement the reform programme within existing SI&T appropriations.
