On 11 September 2025, the Cabinet Legislation Committee:

- 1 **noted** that, in March 2025, the Regulatory Systems (Economic Development) Amendment Act 2025 (the Act) received Royal Assent, and that Part 15 of the Act, amendments to the Motor Vehicle Sales Act 2003, commences on a date specified by Order in Council;
- 2 **agreed** that Part 15 of the Act commence on 22 October 2025;
- 3 **noted** that the Regulatory Systems (Economic Development) Amendment Act 2025 (Amendments to Motor Vehicle Sales Act 2003) Commencement Order 2025 (the Order) will give effect to the above decision;
- 4 **authorised** the submission to the Executive Council of the Order [PCO 28253/4.0].
