Summary

- 1. On Wednesday, 23 July 2025, from 11.30am to 12.30pm, you will meet with senior representatives from the nine South Island iwi (the South Island Iwi) via Zoom. These are:
 - Ngāti Rārua Olivia Hall, Rōpata Taylor and Shane Graham
 - Ngāti Apa ki te Rā Tō Nicole Akuhata and David Johnston
 - Ngāti Kōata Caroline Palmer and Turi Hippolite
 - Ngāti Kuia Waihaere Mason and Eugene Whakahoehoe
 - Ngāti Toa Rangatira Callum Katene and Helmut Karewa Modlik
 - Rangitāne o Wairau Janis de Thierry, Calvin Hart and Corey Hebberd
 - Te Ātiawa Kura Moeahu and Dion Tuuta
 - Ngāti Tama Anthony Little and Hemi Sundgren
 - Ngāi Tahu / Kāi Tahu Warwick Tauwhare-George and Ben Bateman.
- 2. This meeting provides an opportunity to engage with iwi leaders to discuss:
 - your South Island portfolio and vision for the role
 - opportunities to engage with iwi to achieve shared aspirations
 - the 'Together Te Tauihu' partnership agreement between councils and iwi of the Te Tauihu (top of the South Island) region.

Background

'Together Te Tauihu' partnership agreement

- 3. In December 2023, eight Te Tauihu iwi¹, together with the Mayors of Tasman, Nelson and Marlborough regions, signed the 'Together Te Tauihu' partnership agreement² (the Agreement).
- 4. The Agreement establishes a framework to align the aspirations of all parties and strengthen the top of the South Island as a region. It recognises the important and unique roles iwi and councils play in cultural, social, environmental and economic wellbeing.
- 5. The Agreement is built upon five principles:
 - Kotahitanga: Navigating together in unison.
 - Honotanga: Recognising each other's autonomy and mandate.
 - Tauritetanga: Working together to achieve equity in outcomes.
 - Kaupapa Mau Tonu: Looking long-term.
 - Tauutuutu: Fostering reciprocity and mutual benefit.

Topics that may be discussed

Fast-track projects

- 6. Four projects relevant to the South Island Iwi are listed under Schedule Two of the *Fast-track Approvals Act 2024*. Information on the *Fast-track Approvals Act* was provided to you previously (briefing REQ-0011634 refers).
- 7. Three projects relate to Ngāi Tahu:
 - The Hananui Aquaculture project by Ngāi Tahu Seafood Resources Limited, which intends to develop approximately 2,500 hectares of marine space for marine farming.
 - The Pound Road Industrial Development project by Ngāi Tahu Property Development Holdings, which intends to develop industrial land in Canterbury.
 - The Arahura Papakāinga Housing project by Te Rūnanga o Ngāti Waewae³, which intends to develop Papakāinga beside Te Rūnanga o Ngāti Waewae Marae.
- 8. One project relates to Ngāti Koata:
 - The Maitahi Village project by CCKV Maitai Dev Co Limited Partnership, which intends to develop 180 new residential allotments, of which 50 will be Ngāti Koata iwi led housing. The project also includes plans for a retirement village with 194 townhouses and 36 in-care units, and a commercial centre to support the communities. The project lodged an application with the Environmental Protection Authority and has now been referred to an expert panel for processing and decision. Information on the Maitahi Village substantive application under the *Fast-track Approvals Act* was provided to you previously (briefing REQ-0011634 refers).

Crown relations with Māori

- 9. The Treaty of Waitangi requires Crown agencies to consider Treaty principles when carrying out their functions. Treaty principles are primarily concerned with the way in which the Crown and Māori behave in their interactions with one another. These can include: the government's right to govern, the right of iwi to manage their resources, redress for past grievances, equality, and reasonable cooperation by both parties. Public servants are tasked with supporting the Crown in its relationships with Māori under the Treaty.
- 10. As of 2014, all nine South Island iwi have agreed full and final settlement of all historical Treaty of Waitangi claims. As part of these settlements, four Acts were enacted:
 - Ngāi Tahu Claims Settlement Act 1998⁴.
 - Ngāti Apa ki te Rā Tō, Ngāti Kuia, and Rangitāne o Wairau Claims Settlement Act 2014⁵.
 - Ngāti Kōata, Ngāti Rārua, Ngāti Tama ki Te Tau Ihu, and Te Ātiawa o Te Waka-a-Māui Claims Settlement Act 2014⁶.
 - Ngāti Toa Rangatira Claims Settlement Act 2014⁷.

11. These Acts established:

- a formal apology from the Crown and acknowledgement of Treaty breaches
- cultural and economic redress, including recognition of iwi interests in land, heritage, and conservation
- iwi-specific governance entities to represent iwi in dealings with the Crown
- a framework for how the Crown and relevant government departments should engage with iwi on matters of mutual interest, aiming to embed partnership and support ongoing relationships
- the right of first refusal for any Crown land sold within iwi rohe
- protocols and relationship agreements between iwi and government agencies, setting out how engagement should occur on shared interests.

Waitangi Tribunal review

- 12. On 9 May 2025, Hon Tama Potaka, as Minister for Māori Development, announced the Government will undertake a review of the *Treaty of Waitangi Act 1975* (the Act)⁸ in line with the coalition agreement between New Zealand First and the National Party. This is intended to ensure the Waitangi Tribunal remains focused, relevant, effective and fit for purpose.
- 13. The review will assess:
 - whether the Act clarifies the Tribunal's jurisdiction
 - how different types of claims are managed
 - how the Act aligns with other legislation.
- 14. An Independent Advisory Technical Group (the Group), together with Te Puni Kōkiri, will carry out the review. The Group expects to commence engagement with Māori and iwi entities, Treaty law experts, and current and former tribunal members by mid-2025. Advice is anticipated to be provided to Ministers, including Hon Shane Jones, by September 2025 to enable legislative proposals to be introduced before the end of the year.

Nelson Tenths

- 15. In 1839, Māori landowners sold approximately 151,000 acres in Te Tauihu to the New Zealand Company, a British joint-stock company that played a major role in the early colonisation of Aotearoa New Zealand between 1839 and 1858. The primary form of payment for this land was the reservation of one-tenth of the land (the Tenths) for the benefit of the Māori owners and their descendants (the Customary Owners⁹). The Tenths sections were to be one-acre urban, 50-acre suburban and 150-acre rural sections in the new Nelson settlement.
- Only 5,100 acres of Tenths were reserved for use for the Customary Owners, comprised of urban and suburban sections. The remaining 10,000 acres of rural Tenths were never reserved.
- 17. In 2017, the Supreme Court released its judgement on the Tenths¹⁰. It found that the Crown had a duty to act in the best interests of the Customary Owners regarding the Tenths and that it had breached these duties by not reserving the remaining 10,000 acres. The court

- referred the claim to the High Court to determine the liability, loss and remedy in accordance with the Supreme Court judgement.
- 18. In October 2024, the High Court released its judgement¹¹, which directed the Crown pay a sum of money to the Customary Owners. The exact figure is to be calculated with consideration to:
 - the current market value of the land that the Crown no longer holds on trust
 - compensation for the value of the beneficial use of the Tenths
 - the amount which would have been generated according to rentals
 - interest.
- 19. It is expected that before interest, this figure will be less than \$1.00 billion, however, compensation is anticipated to be significant.
- 20. In November 2024, the Attorney General filed an appeal of the High Court judgment. The Court of Appeal will hear the case in April 2026.

Regional Intersectoral Forum

- 21. The Regional Intersectoral Forum (RI Forum) was established in 2001 with the purpose of identifying opportunities and aligning support to advance iwi aspirations for enhanced outcomes for iwi and Māori in Te Tauihu. The RI Forum is an established mechanism to make effective and efficient connections in one forum, reducing effort and duplication.
- 22. The RI Forum's membership consists of leaders of the eight iwi, three councils, and central government agencies¹² in Te Tauihu.
- 23. The forum is co-chaired by Justin Carter (Pouwhakahaere Te Ātiawa) and Craig Churchill (Nelson, Tasman, Marlborough, and West Coast Regional Public Service Commissioner).

Te Kotahi o te Tauihu Charitable Trust

- 24. Te Kotahi o Te Tauihu Charitable Trust (the Trust) was set up in February 2021 with support from the Regional Public Service Commissioner, Ministry of Social Development (MSD), and the eight iwi of Te Tauihu. The Trust has a focus on the communities of Te Tauihu, particularly Māori, with an aim of:
 - advancing health and wellbeing
 - alleviating poverty
 - ensuring adequate food is available
 - promoting education and skills.
- 25. The Trust has delivered various outcomes in the community, including:
 - enabling drivers to obtain licenses through MSD
 - providing Accident Compensation Corporation support services
 - securing two Whānau Ora navigators
 - undertaking stocktake of all emergency containers across the rohe and delivering lock boxes funded by Te Putahitanga to Civil Defence Centres

- placing 53 people into apprenticeships through Kei Aku Ringa Māori Trade Training.
- 26. The Trust is considering additional services, however, the piecemeal contracting and current financial constraints within the Crown funding environment have placed pressure on the Trust, leading the Trust to pursue sustainable options.

South Island challenges and priorities

Kānoa – Regional Economic Development & Investment Unit managed investments

27. Kānoa – Regional Economic Development & Investment Unit manages total approved funding of \$975.00 million of predominantly regional development investments in the South Island and as at 30 June 2025, has paid \$773.20 million into projects in the region. This investment attracted a total of \$1.20 billion in co-investment. Further information on investment into the South Island is provided in the regional dashboard attached at **Annex One**.

Te Tauihu region

- 28. The Te Tauihu region has a number of challenges, including:
 - productivity
 - housing
 - health.
- 29. The Te Tauihu region has 14.7 per cent lower productivity when compared to the national average. To close this productivity gap by 2050, the region's productivity would need to grow at almost twice the national average. The average household income in the region is also 15.9 per cent below the national average. This is driven in part by a large proportion of retirees, however, the region's workforce population also earn less when compared to the rest of New Zealand, with average annual wage earnings 12.8 per cent lower than the national average in 2024.
- 30. Te Tauihu has poor housing affordability, with lack of affordable housing set out as a key challenge in the Nelson City Council Long Term Plan 2024-2034¹³. To address this issue, Nelson City Council (NCC):
 - Established the Housing Reserve Fund (the Fund), with the aim of doubling the number
 of community housing units from 50 to 100 by 2026. The Fund has allocated \$3.85
 million over four grants to not-for-profit community housing providers in the region.
 These providers will develop and provide social and affordable housing, as well as
 accommodation for vulnerable and high needs individuals.
 - Proposed 'Plan Change 29', an amendment to the Nelson Resource Management Plan (NRMP) intended to introduce more flexibility around housing policies and rules. This is aimed at enabling greater housing supply and intensification. The changes are expected to be in operation by September 2025.
- 31. The population aged over 65 years in Te Tauihu is growing at a rapid rate, now representing 23.1 per cent of the population compared to 18.4 per cent in 2013. This is putting pressure on healthcare services in the region, with some general practitioners estimating the over 60 age bracket accounts for up to 80 per cent of primary care appointments.
- 32. In October 2023, 16.7 per cent of Māori in Te Tauihu were not enrolled with primary health care, compared to 4.3 per cent for non-Māori. To reduce inequitable health outcomes in the

- region, Te Piki Oranga (TPO) was established in 2014. TPO is a Māori health services provider which operates in-home, mobile and community outreach services in Te Tauihu.
- 33. On 26 May 2025, Hon Simeon Brown, as Minister of Health, announced the Government will invest over \$500.00 million to upgrade Nelson hospital¹⁴. These upgrades include:
 - Expansion of the hospital's emergency department, set to cost \$11.00 million, and complete in early 2026.
 - Refurbishment and seismic strengthening of the hospital's two main buildings, expected to cost \$73.00 million to design and complete.
 - A new patient building, with 128 beds, an acute assessment unit, a pharmacy, a blood bank, and dedicated areas for assessment, treatment, and rehabilitation services. The building is scheduled to conclude construction in 2029.
 - A modular, portable inpatient unit with a capacity of 32 beds, which will enable ongoing care during construction. This is expected to be delivered by May 2026.

David serves as Director for the Nelson Regional Development Agency and Kururangi Consulting Limited.




Caroline Palmer, Chair, Ngāti Kōata
