Government Releases the Quarter Three Action Plan

The Government has released its Quarter Three Action Plan (1 July - 30 September 2025), outlining 28 priority actions aimed at rebuilding the economy, easing the cost of living, and improving public services. Several of these initiatives present opportunities for the South Island and align with your South Island portfolio priorities.

You may wish to initiate targeted engagement with relevant portfolio Ministers and regional stakeholders to ensure the South Island is well-positioned to benefit from these national initiatives.

Key actions that will support priorities across the South Island include:

- Repealing the ban on offshore oil and gas exploration which may unlock new investment in the South Island, supporting energy sector growth and regional gross domestic product. New Zealand has 18 sedimentary basins, 10 of which are in the South Island. Notably, the Canterbury Basin (approximately 360,000 km²) and the Great South Basin (around 130,000 km²) are among the largest and most geologically promising. These basins have been extensively studied and are now open to exploration following recent regulatory changes. This policy shift is expected to attract new exploration activity, stimulate regional development, and enhance energy security, particularly in regions such as Canterbury, Otago and Southland.
- Ratifying the New Zealand United Arab Emirates (UAE) Comprehensive Economic Partnership Agreement, which will improve market access for key South Island exports such as dairy, meat, and horticulture. Based on information from the New Zealand Ministry of Foreign Affairs and Trade, the UAE is one of New Zealand's largest export markets in the Middle East, with goods and services exports totalling NZ\$1.15 billion in the year to September 2024. New Zealand's key exports to the UAE include dairy, industrial products, meat, horticultural products and travel services.
- Launching a one-off Major Events Fund to boost international visitor growth. While
 no specifics of the fund have been disclosed yet, we will provide further updates
 once decisions have been announced. The fund will have a national focus and could
 support tourism recovery and growth in South Island regions.
- Passing the Public Works (Critical Infrastructure) Amendment Bill to streamline land acquisition for major infrastructure projects. This Bill streamlines land acquisition for major infrastructure projects by replacing court objections with a faster written submission process and offering financial incentives to landowners. It supports projects listed under the Fast-track Approvals Act 2024 and the Roads of National Significance programme, ensuring that once a project is approved, land can be secured more efficiently. For the South Island, this means quicker progress on key developments like transport upgrades and energy infrastructure, particularly in regions like Canterbury, Otago, and Southland, where there are major projects underway in these areas. Although the bill may reduce delays and boost local economies, it also limits legal recourse for landowners (though protected Māori land remains exempt from the accelerated process).
- Implementing the largest-ever annual funding increase for General Practitioner (GP) clinics as part of the Primary Care Action Plan, which will improve access to primary care in South Island regions. As reported in the Otago Daily Times, parts of the South Island, including Canterbury and Southland, are among the most affected by GP shortages. Many clinics are turning away new patients due to staff shortages

- and high demand. For example, Gore Health Centre has been operating a waitlist since October 2024, with doctors managing up to 1,500 patients each and unable to take on more without risking burnout.
- Opening the expression of interest for 120 nurse practitioner training places. Nurse practitioners are a fast-growing workforce, with 859 registered as of December 2024, and over one-third working in primary health care. They can diagnose, prescribe, and manage complex care, complementing the work of GPs and often acting as lead carers. The training support includes funding for course fees, clinical supervision, study time, mentoring, and employer backfill costs. In conjunction with the increase in funding to GP clinics, this initiative is expected to also shorten wait times, improve access to care, and strengthen primary and community health services across New Zealand, including in South Island regions.

Backing Innovation to Grow South Island Aquaculture Exports

On 10 July 2025, Hon Todd McClay, Minister of/for Agriculture, and Trade and Investment, announced a \$0.45 million investment through the Primary Sector Growth Fund to support the development of specialised feed for New Zealand's King salmon, a move expected to significantly benefit South Island aquaculture exports.

The funding supports a \$1.20 million project, led by global aquafeed company Skretting, which will design feed tailored specifically for New Zealand's King salmon. This innovation is critical for the success of open ocean farming, where feed is the largest operational cost. By optimising feed for New Zealand's unique marine conditions, the initiative aims to reduce costs, improve sustainability, and boost farmgate returns.

The announcement aligns with the final resource consent for Blue Endeavour, New Zealand's first open ocean salmon farm, located off the Marlborough Sounds. Once operational, Blue Endeavour is expected to produce 10,000 tonnes of salmon annually, generating up to \$300.00 million in export revenue.

With 100 per cent of New Zealand's commercial salmon farming located in the South Island, the impact of this investment will be felt most strongly in regions such as:

- Marlborough Sounds, which accounts for 47 per cent of national production
- Southland, including Big Glory Bay and Stewart Island, contributing 32 per cent
- Canterbury, including Akaroa and the Mackenzie hydro canals, producing 21 per cent

This investment directly supports regional producers and strengthens the South Island's role in high-value, low-impact food production. It also complements the launch of Invest New Zealand, which aims to attract global innovators to invest and grow in Aotearoa. This initiative represents a practical step toward doubling the value of New Zealand's exports over the next decade, backing science and technology to lift productivity and global competitiveness in the aquaculture sector. New Zealand salmon exports increased past \$200.00 million in 2024, with Salmon exports surging 20 per cent from the previous year. This was driven by strong demand for chilled and frozen products in key markets like the United States of America, and China.

Investing in resilient, reliable infrastructure

On 3 July 2025, Hon Shane Jones, Minister for Regional Development, and Hon Mark Patterson, Associate Minister for Regional Development, announced more than \$56.00 million in funding through the Regional Infrastructure Fund (RIF) to support three water resilience projects in rural Canterbury. The funding is aimed at improving long-term water security, supporting high-value land use, and enhancing climate resilience.

The projects include:

- Opuha Dam and Irrigation Scheme Up to \$20.80 million for infrastructure upgrades to improve flood management, water quality, and seismic resilience.
- Balmoral Water Storage Facility (Amuri) Up to \$20.00 million to construct a 10 million cubic metre storage pond for an existing irrigation scheme.
- Waimakariri Irrigation Scheme Up to \$15.60 million to develop a large-scale water storage facility to improve year-round reliability.

These projects are expected to deliver regional economic benefits, strengthen climate resilience, and serve as models for sustainable rural infrastructure. Importantly, they will provide long-term benefits to the agriculture sector by enabling more reliable irrigation, supporting land use diversification, and improving productivity across a range of farming systems.

Selwyn Sets Benchmark for Local Water Delivery

On 8 July 2025, Hon Simon Watts, Minister of Local Government, announced that Selwyn District has become the first council in New Zealand to launch its new water services entity, Selwyn Water, under the Coalition Government's Local Water Done Well policy. The policy aims to empower councils to deliver safe, affordable, and locally managed water services through transparent governance, community accountability, and scalable infrastructure solutions.

Selwyn District Council is the first to have its Water Services Delivery Plan approved by the Secretary for Local Government, Paul James, and to establish a water services council-controlled organisation (CCO). This plan ensures the delivery of safe, reliable, and affordable drinking water and wastewater services that meet health, quality, and environmental standards.

The Commerce Commission will monitor Selwyn Water's performance, particularly in managing projected price increases and ensuring capital investment targets are met. The entity is also expected to maintain fair infrastructure charges to support sustainable growth.

Future partnership opportunities with neighbouring councils are a core consideration in Selwyn District Council's plan. These partnerships have the potential to deliver greater efficiencies, standardisation, and lower costs for consumers. Selwyn Water's constitution allows for expansion, enabling other councils to join and benefit from a regional water services CCO.

Recent population data released by Stats NZ confirms that Selwyn District remains the fastest-growing district in the country, with a 3.9 per cent increase in population in the 12 months to 30 June 2024 (3,200 new residents). Between 2018 and 2023, the District's population grew by 29 per cent, driven by urban expansion in Rolleston, Lincoln, and Prebbleton. This sustained growth highlights the critical importance of scalable and sustainable infrastructure, particularly in water services, to support community needs and future development.

The establishment of Selwyn Water provides a scalable model for delivering compliant, affordable, and future-ready water services. It also lays the groundwork for regional collaboration and sets a precedent for reform under the Local Water Done Well framework.

South Island RIF Project List

Following recent announcements by Hon Shane Jones, Minister for Regional Development, and Hon Mark Patterson, Associate Minister for Regional Development, total announced funding through the RIF for South Island projects has reached \$151.10 million as of July 2025.

This investment supports a wide range of infrastructure initiatives aimed at enhancing regional resilience, productivity, and long-term growth. Projects span multiple sectors and locations across the South Island, with full details provided in **Annex One – RIF Project List July 2025.**

Temporary Accommodation Service Activation – Top of the South Island

The Temporary Accommodation Service (TAS) has been activated in response to recent displacement events affecting communities in the Top of the South Island. This activation follows localised flooding and infrastructure damage that has rendered a number of homes uninhabitable across parts of Nelson, Tasman, and Marlborough.

TAS is now working with affected households to assess needs and provide interim housing solutions. This includes:

- Coordinating short-term accommodation placements.
- Supporting property owners with repairs and insurance navigation.
- Liaising with local councils and Civil Defence Emergency Management (CDEM)
 Groups to ensure a coordinated response.

TAS is a government-led service managed by MBIE. It is activated following emergencies where people are displaced from their homes and require temporary housing. TAS does not provide emergency shelter during the initial response phase (which is led by Civil Defence), but steps in once immediate safety needs are met and medium-term housing support is required.

Key functions of TAS include:

- Assessing housing needs and matching displaced residents with suitable temporary accommodation.
- Facilitating access to rental properties, motels, or modular housing units.
- Supporting recovery planning and transition back to permanent housing.
- Working alongside insurers, local authorities, and welfare agencies.

TAS operates under the National Civil Defence Emergency Management Plan and is typically activated following significant weather events, earthquakes, or other natural disasters.

Christchurch Supercars Round 2026 – date confirmation

In May 2025, the Government confirmed a \$6.90 million Major Event Fund investment to support Supercars Championship rounds in Taupō and Christchurch from 2026 to 2028. The Christchurch event is also supported by ChristchurchNZ (cash and in-kind).

On 25 June 2025, Supercars announced New Zealand dates for the 2026 events. The Christchurch event at Ruapuna Motorsport Park will be delivered 17 - 19 April 2026, following the Taupō event the preceding weekend 10 - 12 April 2026. Public sentiment has been largely positive, with strong support for the event in the South Island.

Tourism sector update

MBIE has released the May 2025 data for the Tourism sector on accommodation, electronic card transactions, and internation travel. The following are the key highlights of these releases for the South Island

Accommodation Data Programme

- In the year ending May 2025, there were 16.5 million guest nights in the South Island, down 1.3 per cent from last year. This represents 42 per cent of total guest nights in New Zealand, which is consistent with last year.
- Otago had the most guest nights (6.2 million) in the South Island, though this is a decrease of 1.2 per cent from last year.
- Canterbury is the only region to record an increase (up 0.4 per cent) to 5.7 million guest nights from last year.

Tourism Electronic Card Transactions

- In the year ending May 2025, domestic visitors spent \$3.40 billion in the South Island, down 4.6 per cent when compared to the same period last year. On the other hand, international visitors spent \$1.60 billion in the South Island, up 4.5 per cent from last year.
- Only West Coast experienced a rise in domestic visitor spending in the year ending May 2025, up 2.0 per cent from last year.
- Southland had the biggest increase in international visitor spending for the year ending May 2025, up 9.0 per cent from last year.

Otago Central Lakes City - Regional Deal

Earlier this month the Government announced it had entered into memorandums of understanding (MOUs) with three regions - Auckland, Western Bay of Plenty, and Otago Central Lakes. The councils involved with the Otago Central Lakes MOU include Queenstown Lakes District Council, Central Otago District Council and Otago Regional Council. The intention is to agree the first deal by the end of 2025, with a further two deals expected in 2026.
