## **Proposed Overseas Travel: Hon Shane Jones – October 2025**

- I seek Cabinet approval to travel to Reno, Nevada from Wednesday 22 October to Thursday 30 October 2025 in my capacity as Minister for Resources and Minister for Regional Development.
- The Prime Minister has approved the travel in-principle, and leave from the House has been approved by the Party Whip.

# **Purpose of Travel**

- The purpose of this travel is to attend the Indigenous Geothermal Symposium, and Geothermal Rising Conference, in Reno, Nevada, where I will serve as a keynote speaker at the Indigenous Geothermal Symposium and present at the Geothermal Rising Conference.
- This travel builds on the launch of the government's Geothermal Strategy at Geothermal week in Taupō and reflects my ongoing commitment to advancing regional development through strategic investment.
- Additionally, as discussed with the Prime Minister I will conduct a series of meetings and engagements intended to promote New Zealand's innovations in supercritical geothermal, reinforcing its global leadership in next-gen energy technologies, promoting New Zealand as an investment destination.
- Officials are working with my office to finalise the programme. These events will provide an important opportunity to:
  - 6.1 Offer a global platform to showcase Aotearoa's leadership in integrating Māori knowledge and rights into geothermal energy projects.
  - 6.2 Enable relationship-building with indigenous leaders and policymakers from North America and beyond, fostering collaboration on clean energy transitions.
  - 6.3 Highlight New Zealand's Supercritical Geothermal Vision. This provides a stage to present New Zealand's innovations in supercritical geothermal, reinforcing its global leadership in next-gen energy technologies.

- 6.4 Advance cultural diplomacy aligning with New Zealand's values of Māori partnership supporting the government's agenda on indigenous empowerment in climate and energy policy.
- 6.5 Showcase innovation highlighting New Zealand's cutting-edge research in supercritical geothermal, and critical minerals.
- 6.6 Attract investment and partnerships, facilitating direct engagement with global investors and developers, opening doors for joint ventures and economic growth.
- I also have meetings planned with other potential investors who have shown an interest in both supporting and setting up business in New Zealand. These engagements align with the Government's broader strategy to attract foreign investment to New Zealand.

- 9 I will be accompanied by two officials from MBIE, whose travel costs will be met by MBIE.
