
Frontier's Final Report was delivered on 23 May 2025

- 1. Frontier Economics' Final Report was received by your Offices on Friday 23 May.
- 2. This meeting provides an opportunity for you to meet with Frontier to discuss their final recommendations and to ask any questions you have about their key findings and advice.
- 3. A key addition since their Draft Report is Frontier's evaluation of a range of options for addressing the most pressing problem the shortage of dispatchable long-duration cover and Frontier's view that the market will not deliver the investment to solve this problem. You may wish to discuss with Frontier why they consider the approach they recommend in their Final Report should be pursued and their concerns with the other options considered.

Review steps and timetable

- 4. Ministers set a tight timetable for the Review, to enable timely decision-making by Ministers and Cabinet. The Review phases and timelines, consistent with the Terms of Reference, are shown in Figure 1 below.
- 5. Receipt of Frontier's Final Report marks the beginning of the next phase of the Review a two-week peer review of the Final Report by the two international Peer Reviewer teams engaged for this purpose. Reports from the two Peer Reviewers are due on 6 June.
