Designating the Electricity Retail Sector under the Customer and Product Data Act 2025

Portfolio **Energy / Commerce and Consumer Affairs**

On 9 December 2025, the Cabinet Expenditure and Regulatory Review Committee:

- 1 **noted** that the Customer and Product Data Act 2025 (the Act) is a mechanism for allowing customers to require data held about them to be shared safely and securely with them and trusted third parties;
- 2 **noted** that in April 2025, the Cabinet Economic Policy Committee agreed to designate the banking sector under the Act (open banking) [ECO-24-MIN-0039];
- 3 **agreed** to designate the electricity sector under the Act, as per the scope and regulatory settings in Annex 2 to the paper under EXP-25-SUB-0127;
- 4 **authorised** the Minister of Commerce and Consumer Affairs and the Minister for Energy (the Ministers) jointly to clarify and develop policy matters relating to the proposals in the submission under EXP-25-SUB-0127, in a manner not inconsistent with the policy recommendations contained in Annex 2, and consistent with the general policy intent;
- 5 **noted** that some detailed requirements will be prescribed through standards issued by the Chief Executive of the Ministry of Business, Innovation and Employment;
- 6 **agreed** that the scheme be fully funded by fees and levies, as enabled under the Act;
- 7 **invited** the Ministers to report back to Cabinet by July 2026:
 - 7.1 on the administrative costs for the electricity scheme;
 - 7.2 with a proposal on the quantum of funding to be recovered by fees and levies, and their attribution between participants, following targeted consultation;
- 8 **invited** the Minister of Commerce and Consumer Affairs to report back to Cabinet by July 2026 with an update on open banking;

Legislative implications

- 9 **invited** the Minister of Commerce and Consumer Affairs to issue drafting instructions to the Parliamentary Counsel Office to give effect to the decisions above.
