# 3. Work Programme Updates

## 3.1. **OIA18-25** – \$9(2)(a)

Scott Walker

This OIA request is for documents relating to the second phase of the Rural Broadband Initiative (RBI2) and Mobile Black Spot Fund. The proposed response, due to your office this week, is proposing to release comprehensive information on these two programmes. The proposed response may lead to further information requests or follow-up questions from the requester.

### 3.2. FM Sound Broadcasting – Expressions of interest (EOI)

In the 23 March 2018 status report we described the existing process of offering spectrum licences for FM sound broadcasting and received your agreement to continue with that process.

We have now advertised for expressions of interest for licences covering three small population centres (Mount Burnett – Collingwood; Mount Mary - Twizel; and Mount Rochfort - Westport). There was no competing application for the Mount Rochford licence so we will now offer that to the initial applicant at the reserve price (\$5,942 incl gst).

Competing applications were received for the other two licences. As per the agreed process these will now be auctioned. Reserve prices are \$8,088 for Hill End and \$1,678 for Mount Mary. We are currently contracting with a third party to run a small auction via the TradeMe website, reporting back to the Ministry with the winning bids.

### 3.3. **5G network interference management**

We have a time for discussion with you of the overall 5G strategy tentatively scheduled for 18 June.

In parallel with that policy work, we are working on technical aspects of 5G implementation. In particular, there are aspects of the proposed 5G technology that create new interference management issues. These will impact on how we allocate spectrum for the new services.

We recently held two workshops for industry network managers to discuss these issues. Representatives from equipment manufacturers, fixed and wireless internet service providers, the satellite industry and the mobile network providers attended.

Participants shared information and agreed on the next steps to resolve the identified issues. Industry will lead two critical pieces on work on network coordination. We envisage further workshops and information sharing to continue over the coming year as 5G equipment standards are finalised and manufacturers begin producing prototype 5G equipment.

#### 3.4. Telecommunications Resilience Review

In the 20 April 2018 status report, we informed you on the release of our closed tender RFP seeking a supplier to provide us with a natural hazard risk assessment. The risk assessment is the next step in our review of how well New Zealand's nationwide telecommunications services are designed for and able to respond to natural hazard events.

We received two responses to the RFP and this week both respondents made presentations to us in support of their proposals. We are currently evaluating the proposals and aim to begin contract negotiation once a preferred supplier has been chosen.



# 6. Sector News/Other issues you should know about this week

### 6.1. Huawei Global Connectivity Index 2018

For the past five years, the Global Connectivity Index has tracked investment trends in ICT infrastructure, as well as the relationship between digital maturity and economic growth. This year they have expanded the scope of the study from 50 to 79 countries, presenting a broader view of how different nations around the world are preparing for the digital economy.

New Zealand has been ranked 15<sup>th</sup> and has been identified as a frontrunner and a rising star in the digital economy space. Frontrunners are the nations with advanced ICT infrastructure reaping the most positive economic outcomes from their ICT investment.

### 6.2. **2018 World Competitiveness Rankings**

The World Competitiveness Rankings (WCR) has been produced annually since 1989 by the International Institute for Management Development (IMD). New Zealand was ranked 23rd in this year's World Competitiveness Rankings. This compares to the 16th spot in 2017 and 2016, and it is New Zealand's lowest overall ranking since 2013 (25th). The 2018 WCR assessed the competiveness of over 60 countries by combining 250 indicators (official statistics and executive opinion surveys) into four main categories.

New Zealand's rank in each category (and change from 2017) is:

- 33rd in Economic Performance (-1)
- 7th in Government Efficiency (-2)

- 28th in Business Efficiency (-8)
- 25th in Infrastructure (-2).

The fall in the Business Efficiency group was driven by a fall in all five sub-factor rankings: Productivity and Efficiency (49th, -13), Labour Market (26th, -12), Finance (23rd, -9), Management Practices (30th, -11), and Attitudes and Values (20th, -8).

The report also highlighted specific challenges for 2018. These include: high living costs, low wages, lack of senior leaders with international experience, uncertainty over new immigration policies, market concentration in many parts of the economy, poor business readiness for the digital economy, underdeveloped capital market, wealth inequality, overall low trust in business, and infrastructure issues in Auckland.

As in 2017, the five most competitiveness countries were the United States, Hong Kong, Singapore, Netherlands, and Switzerland. Australia was ranked 19th, moving up two spots.

MBIE is hosting a presentation of the results on Wednesday 13 June. This includes an assessment and a Q&A session with the IMD's Chief Economist (via web conference), and followed by a panel discussion.

#### 6.3. **UK emergency services network**

Recent <u>media reports</u> from the UK indicate that the project to move the UK's emergency services off their current land mobile radio (LMR) network and onto one that uses commercial cellular services is 5-10 years behind schedule. The current LMR network may need to continue in operation for this extended period.

The existing LMR network is also from a commercial supplier and extending that contract past its previous expiry date is proving very expensive for the government (at least NZ\$680 million per year in additional funding). Capital costs for the new cellular solution are also increasing.

### 6.4. 2degrees achieves second-ever profit

2degrees has reported a profit of \$19 million for the year ending 31 December 2017. Profit increased from \$14.3 million last year (up 33 per cent). Revenue increased 4.3% to \$732.7 million.

2degrees notes that its results were negatively affected by the problematic launch of a new 'business support system' in February 2017. The launch caused problems for a large number of its customers and generated weeks of long call waiting times.

It notes that it did successfully launch a number of innovative products in the last year:

- A 'data clock' service where customers can purchase unlimited mobile data for certain periods of time.
- An unlimited mobile data product.
- Wi-Fi calling, which enables customers with compatible phones to make phone calls over Wi-Fi even if they do not have cell coverage.

2degrees also recently reported that its more lucrative post-paid customers had risen to 396,000 (up 1.1 per cent) while its number of pre-paid customers had fallen to 1.421 million (down 1.3 per cent). By comparison Spark and Vodafone have approximately 2.5 million total mobile connections each.

Its number of fixed broadband customers rose to 69,000 (up 23 per cent). It has the fifth-largest broadband market share, after Spark, Vodafone, Vocus and Trustpower.
