# **1. Provincial Growth Fund Proposals**

#### West Coast

#### Comment:

As at 1 August 2018, 37 applications from the West Coast region have lodged in PipeDrive. These are predominantly for tourism and infrastructure funding. Three applications will be considered by the Independent Advisory Panel (IAP) on 15 August in advance of consideration by Regional Economic Development (RED) Ministers on 3 September.

The West Coast is finalising its new Economic Development Strategy for 2018 to 2025. It's vision is that the West Coast will become a thriving and prosperous region that will work together to drive innovation through better utilisation of its unique natural resources that will foster economic growth, while caring for communities and the environment. The Strategy is expected to be finalised in September.

#### Tairāwhiti

#### Comment:

Officials from the Provincial Development Unit (PDU), Ministry of Transport (MoT) and NZTA have developed a package of projects, emergency works, investigations and a five year pipeline of road projects for Tairāwhiti. This package includes:

- funding to cover Gisborne District Council's local share for approved National Land Transport Plan projects;
- improvements to the road network in the region, including greater resilience against severe weather events.

The Tairāwhiti Economic Action Plan (TEAP) met with IAP members in Gisborne on 28 July 2018. The newly appointed Senior Regional Official for Tairāwhiti attended his first meeting of the TEAP Steering Group on 1 August 2018. To ensure the region is able to leverage employment and training opportunities from the Provincial Growth Fund (PGF), a TEAP employment/skills sub-committee has been established.

#### Comment:

# The Crown-Māori Economic Growth Partnership , He kai kei aku ringa

He kai kei aku ringa (HKKAR) and the ERERE action plan is currently being updated to better reflect the current government priorities. Workshops have been held with various agencies and a summary of workshop findings is being prepared. An aide memoire will be provided to Ministers next week outlining the initial findings of the workshops and the approach going forward.

A Ministerial briefing will follow that will include the updated ERERE action plan, and high-level targets with a likely timeframe being the end of August. Following this, further work will be undertaken to define the specific indicators required for the updated action plan. A cross government working group is being formed to design and develop an ERERE indicators framework. Next Steps:

A HKKAR Cabinet Paper will be drafted and submitted with the final updated ERERE action plan targets and indicators at the end of September 2018.

## 4. Skills and Employment

#### Employment in the dairy sector

#### Comment:

The Secter Workforce Engagement Programme (SWEP) has been working closely with the Primary ITO and Federated Farmers for the past 18 months to develop the Federated Farmers Dairy Apprenticeship programme. As part of the programme, employers have to demonstrate that they meet minimum employment, training, health and safety standards, and can offer employee support as well as a professional development plan. The value of the programme is that apprentices will "earn while they learn", develop their skills onjob and grow their careers.

Over 170 employers have expressed interest in the programme. Of those, 90 have been approved. There have been over 200 registrations of interest from apprentices located in Manawatū-Whanganui, Wairarapa and Taranaki. Currently there are 39 apprentices on the programme. The aim is to have 150 across New Zealand by July 2019.





