1. Provincial Growth Fund Proposals

Kaikōura District Council

Comment:

Kaikoura District Council has been awarded funding of up to \$200,000 to engage a consultant to undertake feasibility and completion of business cases for three projects: The Marine Centre of Excellence, Kaikoura Airport development, and the Kaikoura Marina development.

The funding will assist the Council in assessing the viability of these projects proceeding and develop business cases. This will include substantial stakeholder engagement, including, but not limited to; Te, Rūnanga o Kaikoura, Ngāi Tahu, Ministries for Primary Industries, Ministry of Business, Innovation and Employment (MBIE), Fisheries NZ, Te Korowai, University of Canterbury, Plant and Food Nelson, Marlborough Hatcheries, NIWA, the Canterbury Mayoral Forum, and local residents and businesses.

While the Council has been advised, this funding has not been announced.

Taranaki

Comment:

As at 15 August 2018, seven applications from the Taranaki region have been lodged in PipeDrive. Of these applications, four relate to large scale commercial companies looking to expand their existing business. Op 15 August 2018 the Independent Advisory Panel (IAP) considered two applications in advance of consideration by Regional Economic Development (RED) Ministers on 3 September 2018. The projects are:

PipeDrive Update

As at 13 August 2018, 424 projects have been lodged in PipeDrive, 29 of these are new this week. Of the 424 projects, 206 are EoIs and 218 are applications. Of the 218 applications, 98 have had funding committed.

ASB/NZTE event in Rotorua

Comment:

On 9 August, Nigel Bickle, Head of the Provincial Development Unit (PDD), and Robert Pigou, Head of Investment Management, attended an ASB/NZTE event in Rotorua to discuss the Provincial Growth Fund (PGF).

The event was attended by approximately 60 people representing the banking private sector, iwi, local economic development agency, and local government.

The presentation focussed on how the PGF works and the types of investments that can be made. The event received positive feedback with significant interest in where the Fund is at, how to access it and what the focus of the Fund is.

Officials also had meetings with four different applicant groups, Rotorua Lakes Council, Te Arawa Primary Sector Group, QE Board and Whakatane District Council Mayor to discuss the PGF financial instruments.
