### 1. Provincial Growth Fund Proposals

#### **Bay of Plenty**

#### Comment:

Progress continues across the Bay of Plenty region, following Ministerial visits on 21 and 22 August 2018.

The Eastern Bay of Plenty has made significant progress in developing a strategy to support the Crown's investment in four infrastructure and connected development projects: Opōtiki aquaculture, high-value horticulture, the Kawerau Putauaki Industrial Development and a Whakatāne tourism and wharf cluster.

Major projects that require either Senior Regional Officials (SRO) or Regional Economic Development (RED) Ministers approval continue to be progressed in the areas of aquaculture, wharf development, food and beverage, water storage, tourism and White Island.

#### Next Steps

Planning is underway for an announcement on 24 September regarding the Rotorua Lakefront Development and Whakarewarewa Forest Park applications.

Initial packages of phased funding for projects in aquaculture, high value horticulture and tourism are expected in November.

#### Hawke's Bay

#### National Aquarium of New Zealand

On 31 August 2018, Under-Secretary Fletcher Tabuteau visited Napier to meet with Napier City Council representatives. The purpose of the visit was to discuss the Council's plans to expand the National Aquarium of New Zealand, and to announce Provincial Growth Fund (PGF) funding for up to \$350k for a stage 2 feasibility study.

#### Hawke's Bay Food Innovation Hub

Sapere Research Group has been appointed to carry out the feasibility study and business case for the Hastings based, Hawke's Bay food hub in Tomoana.

Sapere has extensive experience in completing feasibility studies and business cases in the food, beverage and agri-tech industries.

The project is supported by a PGF grant of up to \$200K, and has region-wide support from the Matariki Executive Steering Group, Business Hawke's Bay, the New Zealand Food Innovation Network, University of Waikato, Maungaharuru Tangitū Ltd, and the Central Hawke's Bay District Council.

#### **Next Steps**

The funding agreement documentation is due to be completed by 14 September 2018.

The feasibility study and business case is planned for completion in early 2019.





#### Southland/Otago

#### The Milford Opportunities Project Governance Group Meeting

The Milford Opportunities Project is having its next Governance Group meeting on 18 September 2018. At this meeting the Governance Group will consider an application for PGF funding. This will be used to produce a conceptual masterplan that responds to the aim of the project (a sustainable response to the growing visitor numbers at Milford Sound/Piopiotahi), and will be the platform for parties to move forward with a collective vision into the future. This master plan is due to be completed by November 2019.

# Visit from Icelandic delegation to Queenstown and Milford Sounds

A visiting delegation from Iceland is coming to New Zealand and will be hosted by local government and business in Queenstown and Milford Sounds on 26-27 September 2018.

This delegation is made up of Minsters and Senior Officials in the Tourism portfolio. The trip is to learn about the issues and pressures facing New Zealand Tourism, and how central and local government is coping with these.

#### Dunedin Engineering Hub

Officials met with Farra Engineering (representing the Dunedin Engineering (Flub) to discuss the approved feasibility funding which will quantify the opportunities available to the industry, and identify gaps in skills and capability that impact on the sector's ability to execute on these opportunities. This will be used to inform a business case for both government and industry to support investment in making our engineering sector more innovative. Investment is likely to include components of upskilling the

workforce, investment in facilities and infrastructure, and increased

investment in research and development.

#### **Next Steps**

PGF application to be submitted to the Provincial Development Unit by the Governance Group.

Officials will support with briefing material where required.

Officials will continue to work with Farra Engineering on this project and keep Ministers updated.



### Progress of applications – 10 September 2018










### Funding by region – 10 September 2018










### Applications by region – 10 September 2018
