2. Regional Updates

2.1 Hawkes Bay

PipeDrive update

As at 8 November 2018, 59 Hawkes Bay applications and expressions of interest (EOIs) have been lodged in PipeDrive.

The status of those applications/EOIs is:

- 19 applications are undergoing assessment
- 13 applications have been approved
- 16 expressions of interest are undergoing assessment
- 11 applications have been declined.

Regional Activity

A Hawkes Bay package is emerging for announcement in 2019. The package currently includes:

- Te Ara Mahi Programme to enhance employment and skills
- Apple and Pear expanding the horticulture industry to meet unsatisfied demand, primarily in the Flawkes Bay
- Roading including Port Access a modest package of roading infrastructure projects
 - Commercial Information
- Māori tourism proposal to meet untapped demand in this area
- Kahutia Possible announcement of the 1B Trees proposal being considered by Te Uru Rākau
- Regional applications based on local priorities.

The Parliamentary Under-Secretary to the Minister for Regional Economic Development will meet with the Hawkes Bay PGF Steering Group and key applicants on 29 November.

2.2 East Coast / Tairāwhiti

PipeDrive update

As at 8 November, there were 34 Tairāwhiti applications and EOIs which have been lodged in PipeDrive.

The status of those applications/EOIs is:

- 17 applications are undergoing assessment
- 17 applications have been approved
- 6 expressions of interest are undergoing assessment
- 2 applications have been declined.

Regional Activity

- A workforce profile is being developed. Key stakeholders include representatives
 from the roading, transport and forestry sectors. The main focus is on
 employment and training options for young people not in employment, education
 or training (NEETs).
- To support the above, registers are being established to capture and record with specificity the numbers, names, and reeds of employers, and similarly for NEETs so practical support can be planned and provided to both.
- A community call to action has been introduced by the PDU Principal Regional Advisor, together with government and regional stakeholders under the mantra C.A.R.E. (Commitment, Action, Reciprocity, Employment.) This will be progressively socialised over the next few months.

2.3 Waikato

PipeDrive update

As at 9 November 2018, 34 EOI and applications from Waikato have been lodged in PipeDrive.

The status of those applications is:

- 7 applications have been approved
- 1 expressions of interest are proceeding to application
- 8 applications have been declined
- 6 expressions of interest will not proceeding to application
- 3 applications and expressions of interest were withdrawn by the applicant
- 7 applications are on hold
- 2 applications are awaiting further info

Regional Activity

- The Waikato Regional Economic Development Programme 2018-2020 Launch is due to be held on November 14th at the Claudelands Events Centre, from 5:30pm 7:30pm. It is an opportunity for the Waikato Economic Development Agency (Te Waka) to discuss the programme of work and regional economic priorities for 2018 2020. Approximately 200 people will be in attendance.
- An inter-agency meeting will be held in Hamilton on November 14th at Waikato Innovation Park. This meeting is an opportunity for agencies to discuss PGF priorities and develop a cross-agency work programme to guide our focus for the next six months. The intention is that this work programme will align with the various regional strategies across the region (e.g. The Waikato Plan, The Waikato Regional Māori Economic Action Plan and the Sub-Regional Waikato Economic Action Plan [SWEAP]).
- A meeting will be held on Thursday November 22nd to form a Waikato Māori Economic Taskforce group that will oversee and provide strategic advice to Te Waka on the roll-out of the Waikato Regional Māori Economic Action Plan. Terms of reference will be developed to guide the activities of this group. The key focus will be to: provide strategic advice on priority projects for implementation, provide a two-way communication channel, to lobby regional resourcing to contribute to PGF-ready projects and to identify risks and risk mitigation strategies if and when required.

Upcoming Announcements

 The region has invited Minister Jones to return to the Coromandel to announce funding for three approved Commercial projects. We are awaiting the confirmation of potential dates for this announcement to occur. Commercial Information

Tourism

On November 14th, Hamilton Waikato Tourism are hosting a Regional Tourism Symposium at Hampton Downs. Tourism continues to be a strong recurring theme throughout the Waikato region. Further work is required to ensure Tainui Waka Tourism have the capability and capacity to ensure Māori tourism operators are engaged with the work of Hamilton Waikato Tourism and that Māori are key players in tourism development in the region.

Hamilton Auckland Corridor Plan

A workshop is being hosted by New Zealand Transport Agency (NZTA) on 8
November at Tūākau Memorial Hall. The purpose of the project is to develop an
integrated spatial plan to establish an ongoing growth management partnership
for the transport corridor between Hamilton and Auckland.

This partnership will accelerate identified transformational opportunities, outline key housing; employment; social; environmental and network infrastructure priorities for the corridor over the next 30 years, successfully accommodate growth and identify planning; development; infrastructure; mitigation and restoration works required.
