2.2 Bay of Plenty

PipeDrive update

As at 15 November, there are 66 Bay of Plenty (BoP) applications and expressions of interest (EoI) lodged in PipeDrive.

The status of these applications/EOIs is:

- 28 applications are undergoing assessment
- 9 applications have been approved
- 17 Eol are undergoing assessment
- 11 Eol and applications are on hold or have been withdrawn
- 1 application has been declined.

Regional Activity

- The Eastern Bay of Plenty (EBoP) package is coming together with 14 applications currently being worked on or approved across three of the four agreed clusters of catalytic infrastructure. These broadly situader:

 - Kiwifruit and other high value horticulture,
 - o Whakatāne Tourism and Wharf Development, and
 - Labour Market Development.
- Te Ara Mahi: Industrial Symbiosis Kawerau (ISK) is developing a proposal for a freight and logistics education hub that will, amongst other skills, develop more heavy-vehicle trained drivers
- PDU Engagement and Commis team were on hand at the Federation of Maori Authorities Inc. (FOMA) national conference in Tairāwhiti and provided information and advice to participants. Targeted collateral was designed for this audience.
- Further to the positive engagement at the FOMA and a follow-up meeting with the FOMA executive, the Bay of Plenty PDU Principal Regional Advisor attended a celebration in Kuratau marking the end of a four year programme incorporating 20 Māori entities.
