2. Regional Updates

2.1 West Coast

PipeDrive update

As at 20 November 2018, 66 applications and Expressions of Interest (EOIs) from the West Coast had been lodged in PipeDrive, consisting of:

- 14 Applications and EOIs awaiting assessment
- 16 were approved
- 7 were declined
- 15 were on hold or needing more information from applicant
- 9 were unsupported EOIs
- 5 were withdrawn

Regional Activity

- On 14 November the USEC visited the West Coast to meet the members of the Provincial Development Unit (PDU) Regional Advisory Panel and to be briefed on the Buller tourism initiatives included in the upcoming Provincial Growth Fund (PGF) investment package for the West Coast.
- The USEC also met with Chief Executives of Buller, Greymouth and Westland District Councils, the Chair and CEO of Development West Coast, the Chairman and Comms Manager of West Coast Regional Council and iwi from Ngati Waewae and was accompanied by the Mayors of Buller, Westland and Greymouth Districts to visit the Kawatiri Dredge in the Greymouth Port which has commenced dredging the lagoon as a result of a \$0.75m PGF grant.
- An energy sector conference/workshop will be held in the region on 27 November to understand the overarching landscape of the energy sector on the West Coast, with a focus on future opportunities and resilience. Sector experts from Taranaki, Trust Power, regional electricity providers, hydrogen specialists, biofuel specialists and waste to energy specialists will be attending. This will give the region and the PDU valuable information to guide future strategy.

Upcoming Announcements

The Prime Minister Jacinda Ardern, Minister Shane Jones, Minister Eugenie Sage and Minister Damien O'Connor will announce the \$140m Provincial Growth Fund investment package for the West Coast on 29 November. The event briefing for the announcement is due to Minister Shane Jones on 27 November.

2.2 Manawatū / Whanganui

PipeDrive update

As at 20 November 2018, 59 applications from the Manawatū-Whanganui had been lodged in PipeDrive.

The status of those applications are:

- 17 were approved
- 16 applications are awaiting assessment
- 10 EOIs
- 11 were declined
- 5 are on hold

Regional Activity

- Team Government Hui: A meeting of Team Government was convened by the Senior Regional Officials (SRO) this week to: prepare for the next investment package announcements in March 2019; plan forward for the next phase of developments to support the Manawatū-Whanganui region; and identify and establish project teams for each area of development priorities involving different agencies as needed.
- **Spatial Planning for Ruapehu:** \$225k has been approved from the PGF by the SROs to complete the spatial planning work in partnership with our national partners, councils, communities, businesses and tangata whenua. DOC and MBIE are assisting Ruapehu District Council develop the scope of the spatial plan and governance of the programme.
- PGF lwi Consultation: PGF officials will work with iwi to encourage Māori involvement in the region, share information and discuss future potential projects. The meeting will take place over three days from 22 to 30 November.
- Accelerate 25: The next Accelerate 25 (A25) Lead Team Meeting is planned for the 14 December 2018. The SRO and key senior officials will be in attendance. The SRO has close contact with the chair of A25 between Lead Team meetings. The focus of interaction with the region is to ensure the proposals being supported through the PGF reflect the priorities of the region.
- PGF PipeDrive: Manawatū-Whanganui region has received a higher than usual number of proposals creating a backlog of applications. The PDU team are working through the applications in the order of date received, acknowledging the need to expedite the process so applicants can be advised as soon as possible.
- SRO Participation: The Manawatū-Whanganui SRO was present at the Minister's announcement event on the 15th November. The SRO also attended the IAP visitation both at the IAP dinner on the 14th November, and was part of their regional visits on the 15th November including their final event which was a meeting with Horizons and iwi partners to discuss the overall regional development, major regional investments and advice from the IAP on how to think about progressing such development.
 - IAP Regional Visit: In parallel to the ministerial announcement, members of the IAP also visited the Manawatū-Whanganui region. The visit provided the IAP with the opportunity to view, and hear first-hand from some of the beneficiaries of the PGF about their proposed projects, the positive impact the fund will have on expediting progress and the benefits derive from those projects for the region and New Zealand.

Manawatū-Whanganui Package Announcement

On 15 November 2018, Hon Minister Shane Jones announced the investment package for the Manawatū-Whanganui region totalling over \$48 million. The investment in the region includes:

- \$40 million going into a regional freight hub near Palmerston North;
- \$2.8 million into expanding the National Driver Training Centre based at Manfeild, near Fielding;
- \$400,000 in the first stage of an Advanced Aviation Hub at Whanganui Airport; and
- \$4.5 million to improve digital connectivity in the region.

Over 200 guests attended the announcement including representatives from central and local governments, private sector and iwi.

2.3 Southland

PipeDrive update

As at 20 November 2018, 38 applications from Southland have been lodged in PipeDrive.

The status of those applications is:

- 17 are being assessed
- 9 have been contracted or are being contracted
- 4 have been declined
- 3 are awaiting further information
- 5 have been withdrawn by the applicant or were unsupported.

Regional Activity

- SROs met with Southland Councils in early October.
- The Head of the PDU attended BusinessNZ Invercargill event and met with representatives of HW Richardson; PowerNet; Southport; Sanford; Mataura Valley Milk; Invercargill Licensing Trust; and Longbeach Holdings [who are agencies involved with PGF funded projects]. He also undertook other meetings with Ngai Tabu, invercargill City Council; Southland Regional Development Strategy and IAP Panel member, Sarah Brown.
- In the corning weeks, the PDU Senior Regional Advisors for the region will be meeting with Regional stakeholders including: Ngāi Tahu; Invercargill City Council: Southland District Council; Gore District Council; Environment Southland; PowerNet; Venture Southland; Invercargill Brewing Company; SouthPort; Auld Distillery; Oreti MAR Limited; HWCP Management; SBS Bank; HW Richardson Group; Invercargill Airport Limited and Stabicraft.

No upcoming announcements are planned for Southland.

3. Other Updates

3.1 Regional Māori Business Meetings

Four regional Māori business meetings in Tauranga, Gisborne, Hastings and Nelson over two weeks saw 205 people attend. Given the mid-week, 9-3pm timeframe, attendance, participation and engagement was very encouraging from communities which included Māori land trusts, Māori-owned SMEs and representatives from local Government and the private sector. Two MEDU staff led the MBIE team which was further complemented by colleagues from Provincial Development Unit, Vision Matauranga and Business.govt.nz. The 2018 series will inform planning for another four or five hui in other regional areas for 2019.
