2. Regional Updates

2.1 Kāpiti

PipeDrive update

As at 4 December 2018, there are 13 applications from the region active in PipeDrive.

The status of those applications is:

- 12 have been initially assessed and are on hold at the request of the applicant
- 1 is currently being assessed.

Kāpiti Coast District Council submitted 12 of the 13 applications on behalf of the region. Those projects are now all on hold at the Council's request for further consideration while they update their long term plan. Applications currently in PipeDrive will be reviewed after 13 December 2018

There are a number of additional potential applications being discussed in the region that are expected to be lodged with the Provincial Growth Fund (PGF) over the coming months.

Regional Activity

Meetings have been held in the region where elected members were briefed in Council Chambers. In addition to this, the Senior Regional Official (SRO) and the Senior Regional Advisor (SRA) attended an Iwi-lead tour of Ōtaki focusing on the issue in this town.

In November, the SRO and SRA facilitated a public meeting attended by 96 people, followed by a workshop with over 60 people on the Kāpiti Coast. Support was provided by Wellington Regional Economic Development Agency (WREDA), Greater Wellington Regional Council and the Kāpiti Coast District Council.

Regional Advisory Group chaired by Privacy of natural persons has been established to provide advice around applications. The Regional Advisory Group will assess applications against the PGF criteria and work through their regional priorities with assistance from WREDA and the Provincial Development Unit (PDU).

Upcoming Announcements

There are no upcoming announcements planned for Kāpiti Coast. We expect to have a package of support ready for announcement around May/June 2019.

2.2 Wairarapa

PipeDrive update

As at 4 December 2018, 4 applications from **Wairarapa** have been lodged in PipeDrive. The status of those applications is:

- 3 have been received
- 1 is awaiting further information.

Regional Activity

A Governance Group has been set up in Wairarapa to provide advice and support for the Wairarapa Economic Development Strategy. The group is Chaired by Privacy of natural persons and will assess applications against the PGF criteria and work through their regional priorities, with input from WREDA and the PDU.

The first Wairarapa Economic Development Strategy for the region was released at a function Minister Jones attended with support from SRQ and the SRA.

The key focus areas of the new Strategy include: value-added food and beverage, visitor and tourism and knowledge-intensive industries (three key industry sectors); housing, knowledge and skills and business development (three key people enablers); and rail, air, water and trees (key infrastructural and environmental enablers).

Further work is being done in the regions to ensure lwi are involved in discussions and aware of the opportunity for PGF to support economic development aspirations.

The SRO visited the region in the last week of November with support from the Ministry of Primary Industries.

A cross agency hui was held this week, with representatives from across government departments looking at key issues, and prioritising work programmes in the region.

2.3 Canterbury

PipeDrive update

As at 5 December, 33 applications from Canterbury have been lodged in PipeDrive. The status of those applications is:

- 10 have been approved
- 2 are being assessed
- 10 are awaiting assessment
- 3 are on hold/awaiting further information from applicants
- 6 have been declined
- 2 have been withdrawn.

The PDU has announced the approval of \$200,000 for the Kaikoura District Council's feasibility studies for a Marine Centre of Excellence and airport and marina developments.

2.4 Northland

PipeDrive update

As at 4 December, 159 applications and Expressions of Interest (EOIs) from Northland have been lodged in PipeDrive. The status of those applications/EOIs is:

- 61 are undergoing assessment
- 7 applications are awaiting decision
- 22 applications are awaiting feedback from the applicant or other agencies
- 5 have been withdrawn
- 3 are on hold
- 34 applications have been approved
- 27 have been declined/unsupported.

Regional Activity

We continue to receive many proposals each week from groups in Northland, most of which are either not 'investment ready' or are not economic development/growth proposals. There is currently a concerted effort to respond to those applicants prior to Christmas so they can approach more appropriate funders or further develop their proposal.

The remaining activity has related to progressing proposals for possible inclusion in packages for announcement.

Upcoming Announcements

The PDU is currently focusing on the development of two packages for announcement in early 2019. These will possibly be focused on a Kaipara package in early February and following that a wider Northland package.

The Kaipara package could include:

- Transport roads, wharves and ferries
- Food production/improved land utilisation
- Tourism possible cycleway.

The Northland package could include:

- Far North several tourism projects, primary sector projects
- Ngawha Innovation and Enterprise Park
- Ngawha Springs Development
- Kaikohe Te Pu o Te Wheke town centre development
- Multiple projects with a focus on employment and skills.

We had no paid advertising on the page this month as we continue to test and evaluate our approach to paid advertising. We expect to resume this programme of digital advertising in the New Year.

A Senior Social Media Advisor will join the Communications team in January 2019 and will use the findings from our social media engagement trial to further expand the reach of our digital channels.

3.2 MBIE Annual Review Hearing – 13 December 2018

MBIE's Annual Review hearing for 2017/18 at the Economic Development Science and Innovation Committee will be held on Thursday 13 December. The PDU has provided input to MBIE's written responses. The contribution has been minimal as the PDU was established in the latter half of 2017/18.

3.3 Proactive Release of PDU Documents

This week Minister Jones' Office met with the Engagement and Communications Team to discuss how the Provincial Development Unit can set up an efficient proactive release process going forward.

The PDU is progressing work to establish a report covering basic information about announced projects, which will answer common questions, including: the date the application was received, the date the project was approved and the SRO/IAP approval and recommendation dates. This report will then be released monthly on the growregions.govi.nz website.

The PDU has established a taskforce to progress the proactive release of key documents ahead of Christmas. They will be released as follows:

- 1. By the end of the week ending Friday 7 December all weekly reports to the Minister and all departmental OIA requests will be proactively released on the MBIE website. We are focused on ensuring strong processes to withhold any information that is not yet ready for public release.
- By the end of the week ending Friday 14 December all remaining Independent Advisory Panel meeting material (agendas, minutes and cover sheets for substantive papers) and remaining Cabinet papers will be proactively released on the MBIE website. We note that there are some documents unable to be proactively released due to pending announcements, including the Cabinet paper "PGF investment in skills and infrastructure".
- 3. By the week ending Friday 21 December all remaining RED Ministers meeting material (agendas, minutes and papers) will be proactively released on the website. As with Cabinet papers, the Minister Jones' Office will need to be approve the papers for publication. We have factored additional time in order for this to be completed.
- 4. By the week ending Friday 21 December some Senior Regional Officials meeting material (agendas and minutes for all meetings, and some cover sheets for substantive papers) will be proactively released.
