### 2. Regional Updates

#### 2.1 East Coast / Tairāwhiti

#### PipeDrive update

As at 12 December 2018, 36 applications and expressions of interest (EOI) have been lodged in PipeDrive. The status of those applications is:

- 3 are being assessed
- 20 have been approved
- 4 have been declined, withdrawn or are unsupported
- 5 are on hold
- 4 are awaiting further assessment following Ministerial decision.

#### **Regional Activity**

The region's greatest barrier to economic growth is the lack of an appropriately trained and skilled workforce. Growing good citizens who can positively participate in and contribute to society and the economy is an essential first step.

Bilateral meetings have been held with key stakeholders inviting them to unify and focus on this as the number one priority for our collective efforts in the region. Meetings have been held with:

- Chamber of Commerce & Employers
- Education Training & Skills providers
- Iwi Chief Executives
- Government Agencies
- Local Government.

An Action Plan is being drafted that will initially focus on four key sectors:

- Forestry
- Horticulture

Civic Construction & Transport

Tourism & Hospitality.

Discussions have started with both the Tertiary Education Commission and education providers to better align their investment with the local economy workforce needs.

A Whenua Māori government agencies project team has been established with the goal of identifying candidates ready to apply to the Provincial Growth Fund (PGF).

The Tairāwhiti Economic Action Plan governance group has received a briefing from Ministry for Primary Industries on the 1 Billion Trees programme and have advised that an information roadshow will take place in the region in late February.

Meetings with existing and potential applicants continue. Reinforcing the productivity criteria is essential for a number of aspiring applicants who are seeking to grow their employee numbers but cannot quantify a product and productivity gain. They have been referred to Ministry of Social Development who have been outstanding partners locally, as have Te Puni Kōkiri, Ministry for Primary Industries and the Ministry of Education.

#### 2.2 West Coast

#### **PipeDrive update**

As at 12 December 2018, 66 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 1 is being assessed
- 17 have been approved
- 26 have been declined, withdrawn or are unsupported
- 5 are awaiting further information
- 8 are on hold
- 9 are awaiting assessment.

#### **Regional Activity**

On 29 November 2018, \$140m of PGF investments were announced on the West Coast by Prime Minister Ardern and Minister Jones at a lunch held at Punakaiki Resort. Also in attendance was Minister O'Connor. The event was well attended by the Mayors of all three West Coast Districts, regional leaders, iwi and local business leaders. Positive feedback has been received as a result of the announcements.

The Prime Minister, Minister Jones and Minister O'Connor also attended three smaller events in the Region:

- Westland Milk Products (WMP), Hokitika with Mayor Bruce Smith, the WMP Management Team and a selection of employees to hear about the new segregation project, the benefits to farmers on the West Coast and the creation of eight to ten new jobs.
- Kawatiri Oredge at Port Greymouth with the Mayor of Greymouth, the CEO of Grey District Council, the Port Manager, and representatives from Westfleet. They were updated on the progress of the dredging and the benefits for the tishing fleet that dredging the port will bring.

Cape Foulwind near Westport with Mayor Garry Howard and local civic and business leaders. The successful applicants gave a brief presentation on the Kawatiri Cycle Trail and the Oparara Basin Restoration projects.

An unscheduled visit was also made to Barrytown School to meet with some local pupils.

#### Regional Engagement

A Provincial Development Unit (PDU) workshop will be held in the region on 13 December which will be attended by Government partner agencies to ensure we are all working together to achieve the best outcomes for stakeholders in the region.

Al Morrison, Senior Regional Official and Penny Bicknell, Principal Regional Advisor will meet with the West Coast regional leaders on 18 December 2018 for a consultation and discussion on Provincial Growth Fund applications and collaboration across the West Coast to achieve the regional economic development objectives. These leaders include: Mayors of Buller, Grey and Westland districts as well as senior representatives of Buller District Council, Grey District Council, Westland District Council, West Coast Regional Council, Ngati Waewae and Development West Coast.

#### 2.3 Bay of Plenty

#### **PipeDrive update**

As at 12 December 2018, 86 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 39 applications are undergoing assessment
- 16 have been approved
- 17 EOI are undergoing assessment
- 14 applications have been declined, withdrawn or are on hold.

#### **Regional Activity**

- Advancing contracts for Rotorua 'Big Moves' Project these are largely agreed.
- Putauaki Trust contracts are being finalised to send to applicants for signing.
- Engagement occurring across the region has included meetings between Bay of Plenty (BOP) and PDU staff and the Economic Development agencies in Taupō, Rotorua and Tauranga. Discussions have been centred on sub-regional priorities and how the agencies can support applicants who are seeking information to lodge applications.
- In response to Under-Secretary Tabuteau's request for a tourism planning hui in Te Puke, BOP PDU staff ran a planning day with the wider group interested in developing a tourism venture near the proposed Confidential information entrusted to the group were able to develop priorities to consider in the tourism space. The next step is for the participants to narrow down their options and decide whether or not to lodge an application.
- Following Minister Jones' visit, discussions have been held with BOP PDU staff and confider the information entrusted to confidential information entrusted to the confidential information entrusted to the confidential information entrusted to the are now considering their options in terms of submitting an application.

BOP PDU staff met with Ōpōtiki, Kawerau, Whakatāne and Bay of Plenty Regional Councils to plan for the upcoming announcements and discuss future projects.

- Team Bay of Plenty (our central Government team including Te Puni Kōkiri, Ministry for Primary Industries, New Zealand Transport Agency, Ministry of Social Development, Ministry of Education and the PDU are meeting weekly to finalise our planning for next year.
- Officials met with the business development manager from Scion to discuss the conversion of biomass to biofuels and the opportunities that might exist in terms of standing up a hub that can scale-up successful experiments into commercially viable products.
- Ngāti Ranginui and Ngāi te Rangi have been met with.
  BOP PDU facilitated the introduction of <sup>Confidential</sup> information information to potential co-investment partners. We are expecting a revised joint funding proposal in January.
- BOP PDU staff have been working with <sup>Confidential information entrusted to</sup> on three pipeline projects aligned with forestry, horticulture and skills and labour.
- A substantial amount of work has occurred with Te Kaha Gold. Their application will go to the Independent Advisory Panel in January.
- Discussions are ongoing with Miro.

#### **Upcoming Announcements**

The 14th of December announcement for the Eastern Bay of Plenty has been finalised. The overall value of the announcement is \$23.4 million consisting of \$21.5 million for Ōpōtiki and \$1.9 million for Whakatāne. The package includes a mix of aquaculture, high-value agriculture, water storage and multi-sector projects.
