C5. Prohibit win-backs

C6. Help non-switching consumers find better deals

Wack-a-mole again. Better to encourage the rewarding of loyalty by the retailers

C7. Introduce retail price caps

It may as well be government run if this action was enforced.

D1. Toughen rules on disclosing wholesale market information

I'm not sure that this section should be called "placing commercial competition in a straight jacket" rather than "reinforcing wholesale market competition!

The implementation of the proposals in Section D will again require an army of civil servants to enforce and stifle the free market - a free market which was implemented by government in the 90s to provide competition.

D2. Introduce mandatory market-making obligations

D3. Make generator-retailers release information about the profitability of their retailing activities

- D4. Monitor contract prices and generation costs more closely
- D5. Prohibit vertically integrated companies

E1. Issue a government policy statement on transmission pricing

That will do a load of good!! NOT. They have been elected to govern - not make statements

E2. Issue a government policy statement on distribution pricing
