As part of the review process for the latest version of Level 5 I believe it would be most helpfull for existing AFAs and other advisers if the CWG could obtain and make public a detailed summary of the syllabus/content differences between the old National Cert Level 5, the current NZ Cert Level 5 and any future changes if required.

As and existing AFA I found it impossible to clearly establish the differences between the National and NZ level 5 to incorporate in my PDP and CPD as part of my ongoing compliance obligations.

Whilst Strategi and Prof IQ were both pretty quick off the mark to offer "bridging the gap" programs, upon enquiry,

I found neither of them could clearly articulate for me the differences/gaps that were in fact new learning other than some obvious regulatory changes that have taken place since the time of the National Cert.

By making any such changes to the required minimum qualifications more easily available, succinct and transparent it will give adivers the ability to develop more meaningful professional development plans that are relevant to the financial advice/services they provide.
