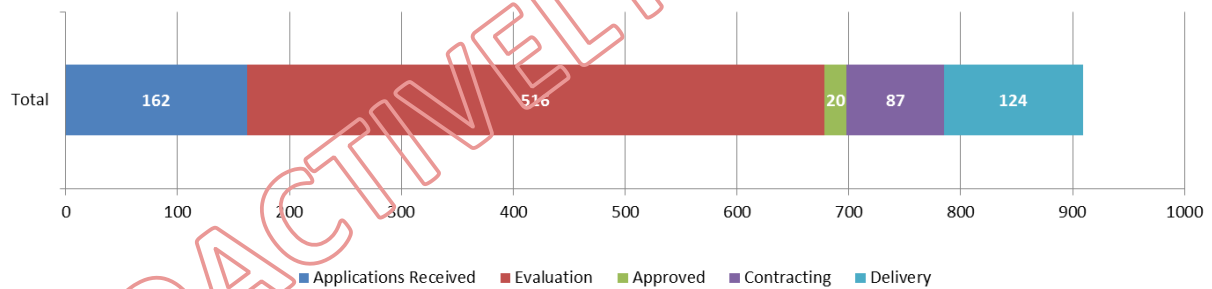

2. Regional Updates

2.1 Otago

PipeDrive update

As of 6 March 2019, 43 applications and EOIs have been lodged in PipeDrive. The status of those applications is:

- 7 are being assessed
- 7 have been approved
- 15 have been declined, withdrawn or are unsupported
- 3 are awaiting further information
- 2 are on hold
- 9 are awaiting assessment

Regional Activity

The Otago Regional Economic Development Strategy Meeting was held on 13 February. This was a chance for the All-of-Government team to meet economic development officers from across the region. The Provincial Development Unit (PDU) provided an overview of the applications from Otago and there was also an information sharing session. The strategy is now progressing for the region and there will be an update on this in the next Otago regional update.

The briefing for the proposed Dunedin waterfront project was also held on 13 February. Dunedin City Council briefed a number of related agencies on its proposed waterfront development. There was a presentation from the City Council, followed by a question and answer session with PDU officials. The business case is now being assessed against commercial criteria by the Investment Management team.

On 14 February, representatives from both the PDU and the Ministry for Primary Industries (MPI) met with prospective Provincial Growth Fund (PGF) applicants in Dunedin and Oamaru. Following these meetings, two industrial tourism applications will be submitted in the coming month. The representatives also visited Invercargill airport, which currently has an application submitted to the PGF which is being assessed.

2.2 Taranaki

PipeDrive update

The Taranaki Crossing:

PGF funding was used to complete a feasibility assessment of a proposed walk across the eastern side of Mount Taranaki. The feasibility assessment is now complete and found a strong case for investment. The report for Ministers is currently being finalised. Taranaki Iwi have been involved in the governance process and have indicated a strong desire to pursue opportunities arising from the enhancement of the crossing, in particular, to submit an application for an enhanced visitors' cultural centre on the Maunga.

H2 Taranaki Roadmap report:

This project included extensive investigations undertaken at the local, national and international level, underpinning a series of business cases for adopting hydrogen technology. The report was completed at the end of 2018 and its findings have been well received. It will be the basis for further development of hydrogen projects and also contribute to a national hydrogen strategy which Minister Woods has commissioned from the Ministry of Business, Innovation and Employment (MBIE). There will be a public launch of the report this month.

Regional Engagement

Officials supporting PGF activity in Taranaki have agreed regional priorities for 2019 and a supporting work programme. Three top priorities identified for increased focus are:

- Strengthening the iwi/Māori economy in Taranaki by supporting increased access to the PGF through expanded support for employment pathways, and initiatives that aim to broaden and strengthen iwi/Māori economic aspirations
- Ensuring applications from across the wider region are supported and are not limited to the city;
- Supporting the advancement of initiatives that will assist a transition of the economy to low emissions or a new foundation.

Meetings have been held with PKW regarding applications to support increased return of rural Māori land, with a key initiative likely to be submitted in the next six months. This initiative is currently in its very early stages and more information will be available in the next Taranaki regional update.

Upcoming Announcements

The Prime Minister is due to announce the H2 Taranaki Roadmap report on Friday 15 March at the Novotel Hotel in New Plymouth. Minister Woods and Under-Secretary Tabuteau will also attend. The event has been organised by Venture Taranaki and the MBIE Just Transitions team.

2.3 Wairarapa

PipeDrive update

Regional Activity

Steering and Governance Groups:

South Wairarapa, Masterton and Carterton District Councils and the Greater Wellington Regional Council (GWRC) have set up two groups to support the delivery of the action plan for the Wairarapa Economic Development Strategy. These will govern and manage the implementation of the Wairarapa Economic Development Strategy and also provide local input into applications seeking funding for local projects, including applications to the Provincial Growth Fund (PGF).

The Wairarapa Economic Development Strategy Steering and Governance Groups can assist in endorsing applications that align with their criteria for decision making (i.e. strong regional support), therefore improving the region's chance of positive outcomes for applications.

PGF, PwC and BNZ Roadshow:

The Provincial Development Unit (PDU) presented at the PGF, PwC and Bank of New Zealand (BNZ) workshop held in the Wairarapa on 6 March. The purpose of this event was to increase local iwi and business awareness of the PGF, to create connections between interested parties and to improve the quality and number of applications. In attendance were local businesses, iwi and community/Council leaders. The initial reception of the event was positive.

Skills Workforce Programme:

The PDU will be providing support to assist Wellington Regional Economic Development Agency (WREDA) and GWRC to deliver a workforce strategy for the Wairarapa. The PDU are contributing to the workforce strategy by bringing together cross-government agencies to provide any data, programme plans and insights to the team from Deloitte. They have been engaged to deliver the workforce strategy for Wellington and the wider regions, including the Wairarapa.

One Billion Trees Fund Information Session:

Te Uru Rākau – Forestry New Zealand (part of the Ministry for Primary Industries) held an information session on the recently launched One Billion Trees (1BT) Fund which was well attended by iwi, landowners, industry groups, councils and others. The session focused on the specifics of applications and the PDU

attended to provide support and ensure that the team is well-informed on all PGF-related programmes.

Cross Agency Support

Central Government agencies are collaborating to support the work of the Provincial Growth Fund. There will be a Wairarapa cross-agency meeting in mid-March to discuss current and upcoming projects.

3. Updates

3.1 Māori Partnerships

3.1 Māori Partnerships

In partnership with Te Puni Kōkiri (TPK) on 4-6 March 2019, PDU officials met with local iwi from Riverton, Invercargill and Bluff (Southland) to discuss economic opportunities through the Provincial Growth Fund and the PGF Whenua Māori fund.

Our responsibility and goal for these hui was to build a relationship with local iwi, identify aspirations and encourage discussion among the four main rūnanga in Southland, specifically about economic opportunities. This will better prepare them to identify suitable projects to submit to either the PGF or Whenua Māori fund if and when they are investment ready.

We received a positive response from local iwi, boards and land trust in these hui. Thoughts and ideas were flowing between members during the meetings.

The four rūnanga are well aware that a package of projects is ideal, and working collectively and collaboratively will decrease submission overlap between entities and preparation time.

The four rūnanga will meet again on 29 March 2019 to identify projects to be submitted to the fund collectively, as well as discuss opportunities to have an investment organisation come in to assist the iwi/rūnanga with feasibility and business cases and the preparation of submissions to the PGF.

On 14 April 2019 team Government for Southland will attend a hui with all four rūnanga, land trusts or boards regarding investment ready projects, and to discuss any other alternative agency support that might be needed for initiatives which are outside of PGF criteria.

We look forward to working more closely with iwi in the South, and have recognised the potential for Māori economies to grow in this rohe.

The next meeting will be 13 March 2019 in Te Tau Ihu.

3.2 Live Dashboard

3.1 Reporting Dashboard

A dashboard has been created to share up-to-the-minute website visitor analytics. Not only does this give a snapshot of our audience – where they're from, when they're visiting and what they're looking at when they're on our site but also gives us measurable data to show how effective the proactive release process is and which issues users are most interested in.

The dashboard contains:

Quick Figures

- Frequently viewed pages
- Location of users

Over time

- Sessions over time – user sessions for this month compared to the previous

month.

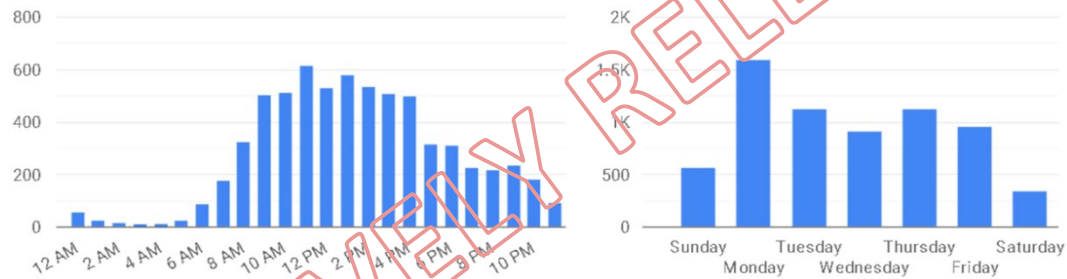
- Which times and days of the week users are visiting

Proactive and data

- Which proactive release pages and papers users are looking at
- Which proactive release files users are downloading.

This week's dashboard shows an increase in time spent viewing the 'Data, statistics and public information' section regarding proactive release papers. With 212 users (an increase of 16.5%) spending an average time of 03.40 minutes (an increase of 31.5%). This also shows viewers navigating through the 'Governance and Decision-making' page through to the 'Independent Advisory Panel', 'Senior Regional Officials' and 'Regional Economic Development Ministers' webpages for more information on the decision making process.

The time/day user data is especially helpful for planning web announcements and content uploads to target a specific audience and ensure an important update isn't lost in a sea of uploads.



'Sessions over time' will be a helpful measure of how the site has gained traction in a short time, giving a snapshot of last month's figures compared to the same day this month. You can see from a glance that the traffic has increased dramatically with the average of 92.04 user sessions in January compared to an average of 223.73 user sessions in February. That's a 250% increase!
