2. Regional Updates

2.1 Te Tau Ihu (Top of the South)

PipeDrive update

As of 20 March 2019, 28 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 2 are being assessed
- 9 have been approved
- 9 have been declined, withdrawn or are unsupported
- 4 are awaiting further information
- 1 is on hold
- 3 are awaiting assessment.

Regional Activity

The recent rainfall across the region has been welcomed, however drought conditions continue and water restrictions remain in place.

The Senior Regional Official (SRO), Investment Director and Senior Regional Advisor (SRA) from the Provincial Development Unit (PDU) have had meetings with a number of applicants in Golden Bay, Nelson and Marlborough. These included the Port Tarakohe key stakeholders, Cawthron Institute, Omaka Aviation Heritage Centre and the Marlborough Research Centre.

The Te Tau Ihu cross-Government agencies held their second meeting on 8 March to agree key milestones for the next six months. The One Billion Trees (1BT) fund was discussed and an opportunity is being explored, as they plan future land use for land owners affected by the recent fires in Tasman.

The Nelson Artificial Intelligence Institute business case continues to progress and the PDU anticipates this to be completed by the end of April 2019.

The Marlborough Smart and Connected Labour Strategy group are identifying key actions they wish to progress to ensure a reliable labour supply.

The Under Secretary Tabuteau (USEC) will announce the 2077 Te Tau Ihu Regional Growth Strategy at an event in Nelson during the week commencing 15 April 2019.

2.2 Waikato

PipeDrive update

As of 20 March 2019, 66 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 6 are being assessed
- 9 have been approved
- 24 have been declined, withdrawn or are unsupported
- 4 are awaiting further information
- 3 are on hold
- 20 are awaiting assessment.

Regional Activity

On 5 March, Tainui Waka Tourism, in partnership with Te Waka and Hamilton Waikato Tourism hosted the Cultural Tourism Symposium at Karapiro. The symposium was well attended and highlighted the abundance of opportunities for the region in the cultural tourism space. Speakers included Kauahi Ngapora from Kaikōura Whalewatch, Pania Tyson-Nathan from New Zealand Māori Tourism and Gerrard Albert, the Chair of Ngā Tāngata Tiaki o Whanganui. PwC facilitated a workshop which prioritised 15 projects for the cultural tourism package. The estimated total of this package is roughly \$80-\$100 million. Te Waka are working to address issues around iw representation and are making progress in this area.

Te Waka met with the USEC in Wellington last week and presented the overall Sub-regional Waikato Economic Action Plan (SWEAP) package outlining some of the growth challenges for the region. Te Waka are developing the application for South Waikato and PDU officials expect to receive this in early April. In addition, the USEC was updated on progress with the cultural tourism package. Te Waka have an express application in the Provincial Growth Fund (PGF) pipeline for capability funding. This application is part of the funding provisionally approved for Economic Development New Zealand (EDNZ). This funding will support Te Waka to build and develop its capability to support PGF applications and projects.

The cross-agency Government team in Waikato are developing a pipeline of proposals for the PGF's Whenua Māori allocations and are also actively working with a Te Ara Mahi proposal that will support skills, training and employment needs in the North Waikato.

The 124th Royal Waka Regatta was held at Turangawaewae Marae on Saturday 16 March. The Regatta was dedicated to those affected by the mosque attacks in Christchurch. Thousands attended and the theme "kia mau te aroha - hei aha te aha!", was drawn from the tongi of King Tawhiao, "hold fast to love, forsake all else".

Māori Economic Development

Te Puni Kōkiri (TPK), alongside Te Waka and Waikato Tainui are leading the refresh of the Maori Economic Action Plan. The refreshed action plan will be launched on 3 May 2019. There is increasing interest from Waikato-based Māori landowners in the PGF's Whenua Māori allocation, therefore PDU officials will

travel to the Waikato and visit landowners to talk about the fund and potential applications. Ministry for Primary Industries (MPI) and TPK are working collaboratively to identify the best support for Māori landowner clients.

2.3 Bay of Plenty

PipeDrive update

As of 20 March 2019, 96 applications and EOI have been lodged in PipeDrive. The status of those applications is:

Regional Activity

PDU officials met with Te Kaha Gold on 5 March to progress negotiations of their funding contract. This meeting included TPK Officials as well as trustees from Te Kaha Gold.

PDU officials continue to engage with iwi across the Bay of Plenty to progress applications and provide information to applicants.

There have been several enquiries from Maori trusts specifically related to the Whenua Māori allocation. Officials are currently working with a number of these trusts to develop their applications

PDU officials attended the Eastern Bay of Plenty Regional Growth Summit held at Te Whare Wānanga o Awanuiārangi on 13 March, there was an excellent presentation on the demographic information within the Eastern Bay and the need to invest in rangatani.

Officials participated in the Eastern Bay of Plenty Horticulture Symposium hosted by TPK and MPI. The symposium attracted more than 80 participants representing wi and Maori land owners/trusts. The morning was dedicated to presentations on kiwifruit, avocados, macadamia nuts, honey, hemp and blueberries. The afternoon included presentations from MPI, TPK and PDU on funding streams and support available.

Minister Jackson opened the new Rangatahi Hub at Te Puna Ora o Mātaatua Charitable Trust (TPOOM). TPOOM is one of the He Poutama Rangatahi (HPR) providers within the Bay of Plenty.

Minister Jackson and Tamati Coffey, MP received a briefing from contractors for the Ōpōtiki District Council on a PGF project to develop opportunities identified through the Eastern Bay of Plenty Regional Growth Leadership Group led by Sir Michael Cullen and Kiritapu Allan, MP.

Contract negotiations continue with the relevant organisations who have had applications approved.

In November 2018 Regional Economic Development (RED) Ministers approved \$6 million for Matai Lab to establish a Magnetic Resonance Imaging (MRI) lab in Gisborne. We are engaging with the applicant to finalise a funding agreement and are looking to confirm a possible announcement date, with the view to compiling a programme of engagements for the Minister of Regional Economic Development.

Given the nature of the project, it may also be worthwhile to engage the Minister of Research, Science and Innovation and the Minister of Health to make a joint announcement alongside the Minister of Regional Economic Development.

This is a particularly newsworthy story and we are awaiting an indication of the Minister's availability to visit Gisborne/ Tairāwhiti for announcement logistics.
