

### 2. Regional Updates

#### 2.1 East Coast/ Tairāwhiti

#### PipeDrive update

As of 27 February 2019, 52 applications and EOIs have been lodged in PipeDrive. The status of those applications is:

- 8 are being assessed
- 21 have been approved
- 12 have been declined, withdrawn or are unsupported
- 4 are awaiting further information
- 6 are on hold
- 1 is awaiting assessment.

#### **Regional Activity**

#### Tairāwhiti Roading

The Senior Regional Officer (SRO) has established a joint governance group, with representatives from New Zealand Transport Agency (NZTA), Provincial Development Unit (PDU), Ministry of Social Development (MSD) plus the Gisborne District Council and iwi. The Group will oversee the roading contract and will ensure that social procurement aspects, primarily relating to jobs for locals, are included.

#### Whenua Māori

Agencies have combined to identify Māori landowners requiring support to submit PGF Whenua Māori applications.

#### Workforce Capacity and Capability

Sectors which have identified the lack of an available and skilled workforce as the single largest barrier to growth. A forum of key stakeholders will develop sector priorities, plans to harness and coordinate local resources.

#### **Rural Coverage**

The PDU will meet with small town trusts and cooperatives in March. The meetings will identify how local communities can better participate in the economy, can improve employment outcomes and achieve sustainable economic growth, further identifying opportunities for connection with our programmes. This work will occur mainly through the PGF-related Te Ara Mahi and He Poutama Rangatahi programmes.

Ministers Jackson and Sage launched Ka Hao te Rangatahi land management training programme at Te Heapara marae in Ruatoria on 15 February. Ten enthusiastic and engaged youth are now enjoying this opportunity offered by Department of Conservation (DOC), Eastern Institute of Technology (EIT) and funded by He Poutama Rangatahi.

#### **Upcoming Announcements**

#### Māori Business Scale Up

TPK and the local economic development agency (Activate Tairāwhiti) have agreed to co-host a forum in late March or early April. The purpose of the forum is to increase the number of applications from local business' to the PGF, Te Ara

Mahi and H	le Poutama Rangatahi.

#### 2.2 Northland

#### **PipeDrive update**

As of 27 February 2019, 177 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 26 are being assessed
- 46 have been approved
- 63 have been declined, withdrawn or are unsupported
- 11 are awaiting further information
- 6 are on hold
- 25 are waiting assessment.

#### **Regional Activity**

An announcement was made by Minister Kelvin Davis at Te Ahu community centre, Kaitaia on 27 February for a total of \$8.2065 million in PGF funding. This announcement package included the following projects:

- Kupe Waka
- Te Hiku Sports Hub
- Te Mingi Barge Site Feasibility
- Aupôuri Ngātikahu Te Rarawa (Developing Projects)
- Te Hiku Water Solutions

The package of announcements was themed on investing in the Far North community. With many young people leaving the district for work and education opportunities, the PGF is supporting projects in the Far North that contribute to a strong and welcoming community, as well as job creations and driving economic development.

Following the announcement on 3 February of the Kaipara package at Otamatea Marae, attention is now focused on establishing governance and project management capabilities.

The following announcements are tentatively planned for Te Tai Tokerau:

- 15 March Minister Davis to announce Whangarei Tourism package early afternoon, and;
- Deputy Prime Minister Peters, Minister Davis and Minister Jones in Kaikohe to announce Mid North Package in Kaikohe.
- 5 April Deputy Prime Minister Peters and Minister Jones in the Hokianga to announce Forestry/Marae Connectivity and other land development opportunities (Rangi Point) in Hokianga.
- 12 April Minister Jones to announce Wilson Training Centre and Accelerating our Capability (TAM) in Whangarei.
- Date TBC Ministers Parker and Jones to announce Mid North and Kaipara Water project location TBC.

#### 2.3 Bay of Plenty

#### **PipeDrive update**

As of 27 February 2019, 93 applications and EOI have been lodged in PipeDrive. The status of those applications is:

- 24 are being assessed
- 9 have been approved
- 23 have been declined, withdrawn or are unsupported
- 8 are awaiting further information
- 7 are on hold
- 22 are awaiting assessment.

#### **Regional Activity**

The Eastern Bay of Plenty Regional Development Project Implementation has now been executed. This follows on from the December announcement and will manage and develop the 65 opportunities identified in the Regional Development Project Report.

Stakeholder engagement across the region has included meeting with lwi leaders in Rotorua to present around the Whenua Maori Fund. This meeting was supported by the Ministry for Primary Industries (MPI) and TPK.

Confidential information entrusted to the Government

Weekly conference calls are in place for central government agencies in the Bay of Plenty to ensure that agencies are well connected and are supporting the work of the Provincial Growth Fund.

Contract negotiations continue with the relevant organisations who have had their applications approved. This is an area of focus for the team.

#### 3.1 **Priority updates**

#### 3.1 Matai Lab Announcement

In November 2018 Regional Economic Development Ministers approved \$6 million for Matai Lab to establish a Magnetic Resonance Imaging (MRI) lab in Gisborne. We are engaging with the applicant to finalise a funding agreement and are looking to confirm a possible announcement date, with the view to compiling a programme of engagements for the Minister of Regional Economic Development.

Given the nature of the project, it may be worthwhile to engage the Minister of Research, Science and Innovation and the Minister of Health to make a joint announcement alongside the Minister of Regional Economic Development.

This is a particularly newsworthy story and we are awaiting an indication of the Minister's availability to visit Gisborne/ Tairāwhiti for announcement logistics.
