I bought a ticket from Viagogo for the Celine Dion concert in Auckland.

The seats were not good although we paid huge money for them. We risked air tickets, hotel costs and a strong possibility that the tickets could be fake or sold many times. We got to the Spark venue very early so we would have been one of the first in, in case these tickets had been sold many times. The following day we heard of a few people who had had a bad experience with their Viagogo tickets.

Viagogo also charged me for their conversion to Euros. We were quoted in NZ \$, and I should not be charged for the Euro conversion.

I think price cap is a soft option. I would make it that a person who bought tickets and could not attend, then they would pay for the administration for the ticket to be sold at the original price.

I personally think price cap is a soft option, but maybe a little better than nothing

Price cap on resale tickets:

Option A: Face value + 10%, or Original sale price (whichever is lower)

Why did you choose the option above? Please explain

I really don't like PRICE CAP, I believe the original purchaser should pay for the tickets being resold. So the original purchaser would lose the resale administration costs

My 5th option is

O Option: Original sale price minus 10%

But PRICE CAP is better than nothing

More information disclosure: Do you agree with this option? Why or why not?

I agree with more information disclosure. They indicated that they were the main ticket sellers, and kept on about the seats in a good place and how quickly they were sell, "last chance"

Ban on ticket-buying bots: Do you agree with this option? Why or why not?

Ban bots is a must, also Viagogos ex Australian manager. NZ is a land of everyone having equal chance, I know this is dreaming. There will always be a disappointment of not getting tickets, like the Mission concert. But at least there were tickets available, when they went on sale, unlike Celine Dion.
