Building (Exempt Building Work) Order 2019

Portfolio Building and Construction

On 11 June 2019, the Cabinet Legislation Committee:

- noted that on 1 May 2019, the Cabinet Economic Development Committee (DEV) agreed to add ground moisture barriers as an exemption under Schedule 1 of the Building Act 2004 [CAB-19-MIN-0193];
- 2 **noted** that the Building (Exempt Building Work) Order 2019 will give effect to the decision referred to in paragraph 1 above;
- authorised the submission to the Executive Council of the Building (Exempt Building Work) Order 2019 [PCO 22156/3.0];
- 4 **noted** that a waiver of the 28-day rule is sought so that the Order in Council:
 - 4.1 can come into force on 1 July 2019;
 - 4.2 (aligns with the date the Residential Tenancies (Healthy Homes Standards) Regulations 2019 come into force;
- **agreed** to a waiver of the 28-day rule so that the regulations can come into force on 1 July 2019.
