### Provincial Growth Fund: Report for the Period 1 October 2018 to 28 February 2019

On 1 May 2019, the Cabinet Economic Development Committee (DEV):

- 1        **noted** that in July 2018, Cabinet invited the Minister for Regional Economic Development to report to DEV on progress with the Provincial Growth Fund (PGF) 3 to 4 times a year [CAB-18-MIN-0347];
- 2        **noted** the contents of the submission under DEV-19-SUB-0089, including its associated A3 document, which provide information relating to funding decisions made and the performance of the PGF for the period 1 October 2018 to 28 February 2019;
- 3        **noted** that future meetings of the Regional Economic Development Ministers will include a focus on the delivery of projects and fund disbursement, and the measures that need to be taken to ensure the successful delivery of the projects and work programmes already underway;
- 4        **invited** portfolio Ministers and their officials to work with the Provincial Development Unit to develop an operational plan for potential projects within their respective sectors.
