4.1 Tai Tokerau/Northland

Update on key statistics

As of 5 June 2019, 194 applications and EOI have been lodged in Pipedrive. The status of those applications is:

- 29 await assessment
- 14 are being assessed
- 9 await further information
- 8 are on hold
- 49 have been approved
- 85 have been unsuccessful declined, withdrawn or are unsupported.

Regional Activity

Since the previous update we have made significant progress across Northland contracts. Contracts were executed for Te Mingi Barge, Riverside Hotel and Entertainment Complex, Horticulture NZ and Camera Obscura with several others in the process of being signed.

Northland Ministry for Primary Industries, Provincial Development Unit, Te Puni Kokiri and Te Uru Rakau staff will convene shortly to agree a co-ordinated strategy to promote and implement the Government's Whenua Māori Fund.

PipeDrive update

As of 5 June 2019, 81 applications and EOI have been lodged in PipeDrive. The status of those applications is:

Regional Activity

PDU officials are finalising the remaining four contracts from the West Coast package. Runanga Miners Hall and Oparara Arches will be executed in the next 7-10 days.

The following contracts have now been executed:

- Westport & Greymouth Port Feasibility study
- Punakaiki Master Plan
- Dredging of Greymouth Port Lagoon
- Wilderness Cycle Trail.

On 24 May, PDU officials met with Buller District Council and Westport Business leaders to discuss training and employment initiatives that may be eligible for funding. PDU officials will further investigate whether these initiatives could be managed on a region wide basis.

The Commercial project team are making significant progress toward completing an application by the end of June. The project is being led by Commercial and is a strong collaboration from West Coast stakeholders: the West Coast District Councils, Iwi, Commercial DoC, Development West Coast, Heritage West Coast and Tourism West Coast. A meeting with all stakeholders and PDU officials is scheduled for 20 June to finalise details for the application.

We have received a number of enquiries around Regional Digital Hubs. We have provided the draft business case and aide memoire to all councils and EDAs for their input around locations.

The Minister of Finance has signed the Whakarewarewa Loan. This will now be sent to the Rotorua Lakes Council for sign off. On 4 June a karakia was held to mark the beginning of development work at the Whakarewarewa Forest.

Development of an Employment Strategy and Youth Action Plans

The Prime Minister has asked the Minister of Employment, Hon Willie Jackson, to develop an Employment Strategy. The Strategy will focus on population groups that continually experience poorer labour market outcomes, with a series of action plans sitting under the strategy.

The first Strategy and Youth Action Plan is focused on improving outcomes for young people. The cross-agency Action Plan will look to leverage activities currently housed in the PDU, including He Poutama Rangatahi and the Sector Workforce Engagement Programme (SWEP), as well as collaborating with new and existing initiatives from other agencies, to improve outcomes for young people who face barriers to employment.

Ministerial consultation on the Action Plan is expected to start next week. We will provide you with advice on any implications to the PGF and the PDU.
