# Welcoming Communities Programme: Post-Pilot Expansion and Ongoing Implementation

**Portfolio** 

**Immigration** 

On 21 August 2019, the Cabinet Social Wellbeing Committee:

- noted that the Welcoming Communities Programme is an initiative led by the Ministry of Business, Innovation and Employment, which was piloted across five sites during 2017/18-2018/19 and focuses on supporting local government councils and their communities to create intentionally welcoming and inclusive environments for newcomers;
- noted that the interim evaluation report for the pilot of the Welcoming Communities
  Programme indicates that it is on the right trajectory to deliver its anticipated short-term and medium term outcomes, which include increased community engagement, social connections and social inclusion, and the longer term generation of social, economic, civic and cultural benefits;
- noted that an allocation of accrued Migrant Levy revenue supported the pilot of the Welcoming Communities Programme from 2017/18-2018/19 with ten local government councils across five sites;
- noted that the Minister of Finance and the Minister of Immigration have agreed to a further allocation of accrued Migrant Levy revenue in 2019/20 as a transitional post-pilot funding arrangement for the Welcoming Communities Programme while decisions are made about its expansion and longer term funding, which will support the pilot sites through provision of a third and final year of grant funding, but is not sufficient to support post-pilot expansion or ongoing support for the implementation of Welcoming Communities;
- **agreed** to the post-pilot expansion and ongoing implementation of the Welcoming Communities Programme from 2019/20, which will maintain and build on the momentum created during the pilot and increase its contribution to the wider government work programme focused on increasing social inclusion;
- 6 **noted** that the Immigration Levy is charged to some residence and temporary visa applicants and provides funding for a number of Immigration New Zealand functions, including longer term migrant settlement programmes which have an established evidence base;
- noted that Immigration Levy revenue accrues in a hypothecation account and that this account is currently in deficit and is forecast to return to surplus in 2021/22;

- **agreed** to an additional allocation of Immigration Levy revenue, totalling \$6.665 million over four years (2019/20-2022/23), to support post-pilot expansion of the Welcoming Communities Programme to up to an additional 30 sites, plus \$0.5 million in outyears to support ongoing implementation;
- **noted** that the impact on the Immigration Levy hypothecation account of the decision in paragraph seven above will be a forecast surplus in 2022/23 rather than 2021/22;
