## **Responses to discussion document questions**

1	Do you have any comments of our assessment of the options for approaching directors' residential addresses on the Companies Register?
	I don't think I saw an option that I believe is appropriate. I can't think of an argument why company directors should have their addresses hidden from view at all. My residential address is already published in the Companies Office register, I work from home and my privacy is not violated because it is published in the Companies Office Register. There are far more violations of privacy perpetrated by other government departments and private sector organisations than the Companies Office Could even hope to achieve by publishing residential addresses. Why do company directors deserve the protection of privacy when often their business practices violate their own clients privacy. I think too much is made of and for businessmen who are often no better than a intoxicated driver on a public road. Perhaps publication of residential addresses would improve corporate responsibility and encourage generosity of spirit, both of which are sadly lacking in the corporate world.

**Other comments**
