Background to the Strategy Development Process

- 1. Responsibly Delivering Value A Minerals and Petroleum Resource Strategy for Aotearoa New Zealand: 2019-2029 (the Strategy) will set the Government's long term vision for the minerals and petroleum sector. It is a ten year strategy (2019-2029) that will build a sector supporting the transition to a low carbon and productive, sustainable and inclusive economy. This Strategy will inform the Tranche Two review of the Crown Minerals Act 1991 (CMA), and will guide future Government policy affecting the sector.
- 2. In January 2019, we provided you with the first draft overview of the Strategy [2145 18-19 refers]. On 28 February 2019, you agreed to a collaborative approach to the development of the Strategy [2147 18-19 refers]. On 13 June, we sought your agreement to circulate an early draft for comment with key stakeholders. Changes were made in response to those comments, and following agency and Ministerial consultation, the current version of the Strategy was released for public consultation [DEV-19-MIN-0220]. The Strategy was generally well received.

The final Resource Strategy is attached in Annex Two

- 3. On 27 September 2019, we provided you with a summary of the submissions, and proposed changes to the discussion document [0994 19-20 refers]. These changes included:
 - a. Amending the vision statement to: "A world-leading environmentally and socially responsible minerals and petroleum sector that delivers affordable and secure resources, for the benefit of current and future New Zealanders."
 - b. Commentary under the vision explaining the key terms;
 - c. A list of minor changes throughout the Strategy to improve readability and accuracy of information communicated; and
 - d. Future actions for inclusion under the six action areas of the Strategy.
- 4. We have since actioned these changes into the designed version of the Strategy attached in Annex Two.

Summary of Agency Feedback

- 5. The proposed vision statement, commentary, minor changes and future actions were circulated for feedback to: the Treasury, Department of Prime Minister and Cabinet, Ministry for the Environment, Te Arawhiti, Ministry of Transport, Ministry for Primary Industries, Land Information New Zealand, Department of Conservation, Ministry for Foreign Affairs & Trade, Environmental Protection Agency, Maritime New Zealand and the Ministry of Housing and Urban Development.
- 6. We invited agencies to provide us with any future actions they were undertaking to advance the Strategy in addition to some already comprehensive actions like the Resource Management Act review, but we received a nil response. Therefore, the list of future actions remains constrained to actions that are already within MBIE's work programme. Note that the list of future actions currently in the Strategy is not designed to be exhaustive and will likley expand in the future.

Most agency comments focused on clarifications

7. The Ministry for the Environment sought clarifications to the commentary we propose to include following the vision statement. We have addressed these comments and incorporated these changes in the commentary text.

8. Te Arawhiti, Treasury, and Ministry of Transport provided comments regarding the clarity of elements of the action areas. These comments have also been addressed by improving the clarity of the relevant elements of the action areas.

More 'sustainability' focused actions

- 9. The Department of Conservation (DoC) commented that more actions stressing sustainability themes should be included within action area 2: securing affordable resources to meet our minerals and energy needs, and action area 6: research and investment in better mining and resource use. DoC further referenced that submitters indicated a strong preference for a focus on sustainability and a circular economy.
- 10. We note that "Plan for a circular economy/ōhanga āmiomio" is already included as an action under action area 6. This captures the work programme which is primarily led by the Ministry for the Environment.
- 11. The future actions that are currently noted in the Strategy are constrained to only those actions that are already part of MBIE's work plan. As stated earlier, other agencies provided a nil response regarding their own future actions. Therefore, additional future actions stressing sustainability (or any theme) would potentially lie outside the current work programmes of government agencies. We do not consider it would be appropriate to potentially pre-commit the Government to action through publication in this Strategy without vetting these actions through appropriate Ministerial decision making and Budget bid processes.

Change to the 'no new mines on conservation land' (NNMOCL) action text

- 12. DoC requested that the following text under the NNMOCL action "making sure that mining is done in the right place, in the right way" be replaced with the following: "to ensure New Zealand's public conservation land is managed in a manner that protects and preserves conservation values." DoC informs us that the original text was from an early draft of the NNMOCL discussion document and is no longer relevant.
- 13. We have replaced this text as requested; however, we wanted to raise this to your attention given the focus given to the NNMOCL action in the initial round of ministerial consultation on an earlier draft of the Strategy.

Next steps leading to publication

14. A timeline for the process leading up to publication of the Strategy is noted below:
