What is your vision for the minerals and petroleum sector in New Zealand?

My vision for the sector is that it is curtailed to the extent necessary to protect our environment. People complaining about lost profits or "lost value" from curtailing this sector need to bear the loss. Our environment has no voice to complain about what it has lost and what it stands to lose. Any loss to the economy/productivity from reduced sector profits is acceptable if it is necessary to protect our environment. Increased productivity in other sectors from sustainable industries will outweigh lost productivity in the mining/petroleum industries.

How can New Zealand sustainably derive value from its petroleum and minerals resources?

Only to the extent that this "derivation of value" does not affect our environment. If there is no level of petroleum or mineral extraction that is safe for our environment, these resources should not be used. to "derive value".

Why?

The objectives need to be reversed - carbon neutrality is paramount. If it is necessary to reject objective (a) for the purposes of objective (b), so be it.

Objective for a sector that: "Is productive and innovative".

Why?

This objective MUST be caveated by the phrase "Is productive and innovative ONLY IF there is no effect on the environment and carbon neutral goals."

Objective for a sector that: "Is effectively regulated".

Strongly agree

Why?

Holding the sector to account is of paramount importance. No sector is above the faw. The regulator must be appropriately resourced so that industry participants do not consider that flouting the regulations is a viable risk to take because they might not get caught. The resource strategy should consider creating regulations/legislation that enables the revocation of current sector permits that damage the environment, or that are inconsistent with carbon neutral goals.

The world needs to find a way to do without minerals and petroleum. The "need for minerals and petroleum" must be reduced. The Crown has the ability to incentivise individuals and organisations to reduce their demand for minerals and petroleum.
